(AVENUE B is just past AVENUE C) (Go 0.3 Miles. 501 AVENUE B is on the RIGHT (Destination is just past WATKINS AVE.) (Go 0.01 Miles)

From The West:

Take US-22 E. Turn RIGHT onto PA-981 (Go 6.5 Miles). Turn Right onto PA-981/Industrial Blvd. Make FIRST LEFT onto LINCOLN AVE. (Go 0.9 Miles). Turn RIGHT onto CEDAR ST. (CEDAR ST. is 0.1 Miles past CHERRY ST.) (Go 0.1 Miles). Turn LEFT on LIGONIER ST. (Go 0.3 Miles). Turn RIGHT onto AVENUE B (AVENUE B is just past AVENUE A) (Go 0.3 Miles). 501 AVENUE B is on the RIGHT (destination is just past WATKINS AVE.) (Go 0.01 Miles).
