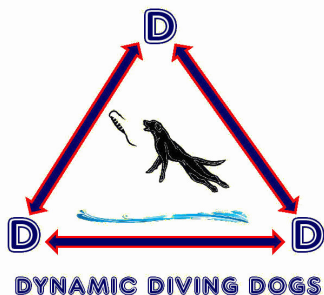

Qualifiers will receive a flat ribbon for successful splashes.  
A "New Title" rosette for any dog finishing a title.

#### Schedule

**Event Hours: 10:00am to finish**

**Limited to 100 Distance Splashes Each Day (maximum 4 per dog)**

**Starting the morning with Arc Air Limit 20 Dogs**

**Fast Fetch Immediately Following Distance on Sunday Limit 25 Dogs**

A registration number is required for entry.  
Dogs may register at the time of entry. \$15 Registration Fee.

#### Event Descriptions:

**Dynamic Distance:** a distance splash consisting of 2 consecutive jumps and 1 optional practice jump. Distance is marked where the base of the tail meets the water. Best of the 2 jumps counts as the qualifying score.

**Arc Air:** dog must successfully grab or knock down a bumper suspended 4 feet over the water (2 feet above the dock). Splash continues until the dog misses 2 times in a row or 3 times total. Furthest distance of successful grab counts as the qualifying score.

**Fast Fetch:** a speed retrieve wherein the dog enters the water from the dock OR ramp and swims to a bumper held at the 40 foot mark, grabs the bumper and returns to the ramp with the bumper. Time starts when the dog crosses the 10 foot mark and ends when crossing the 10 foot mark again with the bumper. Fastest time of 2 retrieves counts as a qualifying score.

#### GENERAL RULES

All Entries must be 1 year of age or older on the day of the event.

Any entry found to be lame, unfit to compete, or female in season, shall not be allowed to enter and their entry fees shall be refunded. The decision of the committee is final.

Dogs may wear any type of flat quick release collar with NOTHING hanging from the collar. NO PINCH COLLARS, ELECTRONIC COLLAR OR FLEXI LEADS ARE ALLOWED ON SITE.

Dogs are permitted to wear a compression shirt and/or a flotation device as long as it is securely fastened and considered to be safe to jump.

Committee reserves the right to bar aggressive dogs from the event site.

The following actions may result in the fine and/or being excused from the event: exhibiting unsportsmanlike conduct or not picking up after one's dog.

## RV PARKING

---

**RV parking area is limited.** RVs must park in designated area. **Reservations must be made in advance.** There is a \$30 charge for RV parking per night (NO HOOKUPS). Limited number of hookups for motor homes or campers are available for \$45 per night. Arrive using Avenue C. 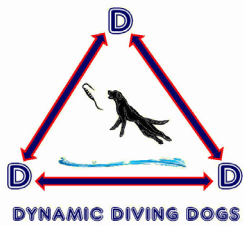
**From the East:** Take I-70/US 30 W. Continue to follow US-30 W. Merge onto PA-982 toward Bradenville (go 1.0 Miles). Turn LEFT onto LIGONIER ST. (LIGONIER is just past DIANE St.) (go 0.3 Miles). Turn LEFT onto AVENUE B. (AVENUE B is just past AVENUE C) (go 0.3 Miles). 501 AVENUE B is on the RIGHT. (destination is just past WATKINS AVE.) (go 0.01 Miles)

**From the West:** Take US-22 E. Turn RIGHT onto PA-981 (go 6.5 Miles). Turn Right onto PA-981/Industrial Blvd. Continue to follow PA-981 S (go 0.5 Miles). Turn LEFT onto LINCOLN AVE./PA-981. Continue to follow LINCOLN AVE. (Lincoln AVE. is just past DEPOT St.) (go 0.9 Miles). Turn RIGHT onto Cedar ST. (CEDAR ST. is 0.1 miles past CHERRY ST.) (go 0.1 Miles). Turn LEFT onto LIGONIER ST. (go 0.3 Miles). Turn RIGHT onto AVENUE B (AVENUE B is just past AVENUE A) (go 0.3 Miles). 501 AVENUE B is on the RIGHT. (destination is just past WATKINS AVE.) (go 0.01 Miles).

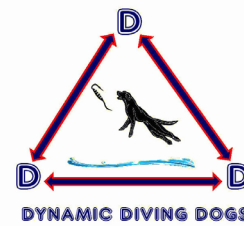
**From the North:** Take I-76 S (Pennsylvania Turnpike). Merge onto US-30 E via EXIT 67 toward GREENSBURG (go 18.9 Miles). Merge onto PA-982 toward Bradenville (go 1.0 Miles). Turn LEFT onto LIGONIER ST. (LIGONIER is just past DIANE St.) (go 0.3 Miles). Turn LEFT onto AVENUE B. (AVENUE B is just past AVENUE C) (go 0.3 Miles). 501 AVENUE B is on the RIGHT. (destination is just past WATKINS AVE.) (go 0.01 Miles)

**From the South:** Take US-119 N. Merge onto US-30 E. Merge onto PA-982 toward Bradenville (go 1.0 Miles). Turn LEFT onto LIGONIER ST. (LIGONIER is just past DIANE St.) (go 0.3 Miles). Turn LEFT onto AVENUE B. (AVENUE B is just past AVENUE C) (go 0.3 Miles). 501 AVENUE B is on the RIGHT. (destination is just past WATKINS AVE.) (go 0.01 Miles)
