From the South: Take US-119 N. Merge onto US-30 E. Merge onto PA-982 toward Bradenville. At 2 nd light, turn LEFT onto LIGONIER ST. Turn LEFT onto AVENUE B. Follow Avenue B to the end, 501 AVENUE B is the white building on the RIGHT.
