### Ribbons & Prizes

Qualifiers will receive a light blue flat ribbon for successful pass of test. TRSSC will offer a "New Title" rosette for any dog finishing their title.

### Schedule

Trial Hours: Saturday & Sunday – 8 AM will be the 1<sup>st</sup> group, 9:30 am will be 2<sup>nd</sup> and 11 am will be group 3. Trials will run concurrently. Please leave after your 2<sup>nd</sup> run.

**Day of Show: 10:30 am arrival time**

Day of Trial Entries will not close unless trial is over or meet maximum number of runs for each trial.

Inspection: All dogs will be inspected for soundness and measured prior to running each run. All bitches will be checked for being in season prior to running each event. Multiple dogs will be spaced.

Electronic timers will be used. We will use break-the-beam equipment to obtain the time.

**Course will be completely fenced in.**

**Fast Cat is a timed straight race of 100-Yards. Dogs run singularly.**

**Dog's time to complete the 100-yard dash is converted into mph. Dog's time divided by 204.545 to figure MPH**

18" or greater = handicap is 1.0

12" up to less than 18" = handicap is 1.5

Below 12" = handicap is 2.0

**Points = MPH multiplied by the dog's handicap**

**FAST CAT suffix titles are earned at designated milestones:**

BCAT = 150 points

DCAT = 500 points

FCAT = 1000 points

FCAT# = each additional 500 points

**Timing Device:** The time to complete the 100-yard dash is recorded to the nearest 1/100<sup>th</sup> of a second. The club will use break-the-beam equipment. In case of inclement weather or failure of timers, 2 stopwatches will be used. An individual at the start line shall signal with an arm drop at the start line. When the nose of the dog crosses the finish line the stopwatches will be stopped. The times from the two stopwatches shall be averaged to determine the recorded time

## GENERAL RULES

All Entries must be one year of age or older on the day of the test.

Each entry will be examined and may be measured with a wicket at inspection. Inspection shall take place before any wraps are applied to the dog. Any entry found to be lame, unfit to complete, or female in season, shall not be allowed to enter and their entry fees shall be refunded. The decision of the field committee is final.

Muzzles are permitted. Dogs may wear any type of flat quick release collar with NOTHING hanging from the collar. NO PINCH COLLARS, ELECTRONIC COLLAR OR FLEXI LEADS ARE ALLOWED ON SITE.

Lures consist of white plastic bags and we will be trying runs with a squawker.

Field committee reserves the right to bar aggressive dogs from the event site.

There is a \$15 fine assessed for any loose dog not taking part in the course progress (per AKC). The following actions may result in the fine and/or being excused from the event: exhibiting unsportsmanlike conduct, not picking up after one's dog, or littering in the area of the event.

1. No One is permitted on the field without the express permission of the Field Chairman, except the appointed Field Committee.
2. There is NO SMOKING in the following areas: In and around the Paddock area, in and around the Secretary's table, and nowhere on the field itself. Please be respectful of others repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made.

## RV PARKING

## DIRECTIONS TO TRIAL SITE

**Address for GPS: 501 Avenue B, Latrobe, PA 15650**

**FROM THE EAST:** Take I-70 / US-30W. Continue following US-30W. Merge onto PA-982 toward Bradenville. (go 1.0 mile). Turn LEFT onto LIGONIER ST (*LIGONIER is just past DIANE St.*) (go 0.3 mile). Turn LEFT onto AVENUE B (*AVENUE B is just past Avenue C*) (go 0.3 mile). 501 AVENUE B is on the RIGHT (*destination is just past WATKINS AVE.*) (go 0.01 miles).

**FROM THE WEST:** Take US-22 E. Turn RIGHT onto PA-981 (go 6.5 miles). Turn Right onto PA-981/Industrial Blvd. Continue to follow PA-981 S (go 0.5 miles). Turn LEFT onto LINCOLN AVE/PA-981. Continue to follow LINCOLN AVE (*LINCOLN AVE. is just past DEPOT ST*) (go 0.9 mile). Turn RIGHT onto CEDAR ST. (*CEDAR ST. is just past CHERRY ST*) (go 0.1 mile). Turn LEFT onto LIGONIER ST (go 0.3 mile). Turn RIGHT onto AVENUE B (*AVENUE B is just past AVENUE A*) (go 0.3 mile). 501 AVENUE B is on the RIGHT (*destination is just past WATKINS AVE.*) (go 0.01 miles).

**FROM THE NORTH:** Take I-76 S (PA Turnpike). Merge onto US-30E via EXIT 67 toward GREENSBURG (go 18.9 Miles). Merge onto PA-982 toward Bradenville (go 1.0 mile). Turn LEFT onto LIGONIER ST (*LIGONIER is just past DIANE St.*) (go 0.3 mile). Turn LEFT onto AVENUE B (*AVENUE B is just past Avenue C*) (go 0.3 mile). 501 AVENUE B is on the RIGHT (*destination is just past WATKINS AVE.*) (go 0.01 miles).

**FROM THE SOUTH:** Take US-119 N. Merge onto US-30E. Merge onto PA-982 toward Bradenville (go 1.0 mile). Turn LEFT onto LIGONIER ST. (*LIGONIER is just past DIANE St*) (go 0.3 mile). Turn LEFT onto AVENUE B. (*AVENUE B IS just past Avenue C*) (go 0.3 mile). 501 AVENUE B is on the RIGHT (*destination is just past WATKINS AVE.*) (go 0.01 miles).
