If an exhibitor is asked to leave the trial site, then the exhibitor will not be refunded any fees that have been paid.

Take I-76 S. Merge onto US-30 E via EXIT 67 toward GREENSBURG. Merge onto PA-982 toward Bradenville. At 2nd light, turn LEFT onto LIGONIER ST. Turn LEFT onto AVENUE B. Follow Avenue B to the end, 501 AVENUE B is the white building on the RIGHT.

From the South:

Take US-119 N. Merge onto US-30 E. Merge onto PA-982 toward Bradenville. At 2nd light, turn LEFT onto LIGONIER ST. Turn LEFT onto AVENUE B. Follow Avenue B to the end, 501 AVENUE B is the white building on the RIGHT.

From the East:

Take I-70/US 30 W. Continue to follow US-30 W. Merge onto PA-982 toward Bradenville. At 2nd light, turn LEFT onto LIGONIER ST. Turn LEFT onto AVENUE B. Follow Avenue B to the end, 501 AVENUE B is the white building on the RIGHT.
