#### **Ribbons & Prizes**

Qualifiers will receive a flat ribbon for successful pass of test. Placements will be awarded for first through third place for jump heights 4, 8, 12, 16, 20 & 24. A "New Title" rosette for any dog finishing their title. All dogs will compete against their jump height.

#### Schedule

Trial Hours: 10 am starts the first dog Second Trial will run after first trial is completed Day-of-Trial Entries needs to be there by 9:30 am

All dogs that do not have a permanent jump height card for any agility venue will have to be measured. Inspection: All dogs will be inspected for soundness and measured prior to running each run. Multiple dogs will be spaced. Electronic timers will be used.

#### Course will be completely fenced in.

Bunny Dash is a timed straight race of 120 feet or 40-yard dash. Dogs run singularly.

Dog's time to complete the 40-yard dash is converted into mph. Formula is 81.9 divided by dogs time.

Double digit dogs = handicap is 10 points

Points = MPH plus dog's handicap

Bunny Dash suffix titles are earned at designated milestones:

Peter = 200 points

Thumper = 600 points

Jack = 1000 points

Enyrgizer = each additional 500 points

Timing Devise: The time to complete the 40-yard dash is recorded to the nearest 1/100<sup>th</sup> of a second. The break-the-beam equipment will be used. An individual at the start line shall signal with ready, set, go at the start line.

Lures consist of white plastic bags and or unstuffed toy

Committee reserves the right to bar aggressive dogs from the event site.

The following actions may result in the fine and/or being excused from the event: exhibiting unsportsmanlike conduct or not picking up after one's dog.


