#### Ribbons & Prizes

Qualifiers will receive a flat ribbon for successful pass of test. Placements will be awarded for first through third place for jump heights 4, 8, 12, 16, 20 & 24. A "New Title" rosette for any dog finishing their title. All dogs will compete against their jump height.

#### Schedule

Trial Hours: Saturday 10 am until completed  
Second Trial on Saturday & Sunday: Will run after first trial is completed  
Day-of-Trial Entries will not close unless trial is over

All dogs that do not have a permanent jump height card for any agility venue will have to be measured. Inspection: All dogs will be inspected for soundness and measured prior to running each run. Multiple dogs will be spaced. Electronic timers will be used.

#### Course will be completely fenced in.

Bunny Dash Sprints is a timed straight race of 240 feet or 80-yard dash. Dogs run singularly.

Dog's time to complete the 80-yard dash is converted into mph. Formula is 163.6 divided by dogs time.

Double digit dogs = handicap is 10 points

Points = MPH plus dog's handicap

Bunny Dash suffix titles are earned at designated milestones:

Lola = 200 points

Bugs = 600 points

Roger = 1000 points

Playboy = each additional 500 points

Timing Devise: The time to complete the 80-yard dash is recorded to the nearest 1/100<sup>th</sup> of a second. The break-the-beam equipment will be used. An individual at the start line shall signal with ready, set, go at the start line.

Muzzles are permitted. Dogs may wear any type of flat quick release collar with NOTHING hanging from the collar. NO PINCH COLLARS, ELECTRONIC COLLAR OR FLEXI LEADS ARE ALLOWED ON SITE.

Lures consist of white plastic bags and or unstuffed toy

Committee reserves the right to bar aggressive dogs from the event site.

The following actions may result in the fine and/or being excused from the event: exhibiting unsportsmanlike conduct or not picking up after one's dog.

## RV PARKING

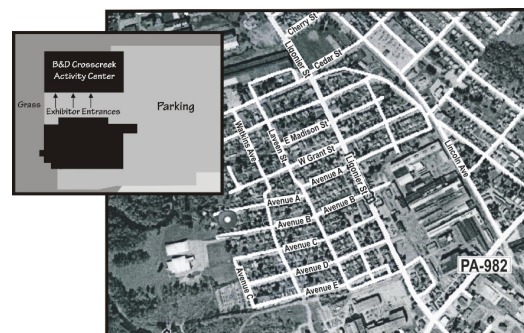

**From the East:** Take I-70/US 30 W. Continue to follow US-30 W. Merge onto PA-982 toward Bradenville (go 1.0 Miles). Turn LEFT onto LIGONIER ST. (LIGONIER is just past DIANE St.) (go 0.3 Miles). Turn LEFT onto AVENUE B. (AVENUE B is just past AVENUE C) (go 0.3 Miles). 501 AVENUE B is on the RIGHT. (destination is just past WATKINS AVE.) (go 0.01 Miles)

**From the West:** Take US-22 E. Turn RIGHT onto PA-981 (go 6.5 Miles). Turn Right onto PA-981/Industrial Blvd. Continue to follow PA-981 S (go 0.5 Miles). Turn LEFT onto LINCOLN AVE./PA-981. Continue to follow LINCOLN AVE. (Lincoln AVE. is just past DEPOT St.) (go 0.9 Miles). Turn RIGHT onto Cedar ST. (CEDAR ST. is 0.1 miles past CHERRY ST.) (go 0.1 Miles). Turn LEFT onto LIGONIER ST.
