ISC CLASS INFORMATION:

Saturday/Sunday: ISC World Team Qualifying Event

This event is also a World Team Bye Event so the following will apply to those who would like to enter the World Team Tryouts for the 2024 Team: "Clean run" scores from Level 2 & 3 ISC Classes at 12", 16", 20 and 24" inches may be used to fulfill the minimum requirements of 4 Std/4 JWW requirements. A "clean run" consists of a run without time or course faults. Minimum YPS requirements are waived for these scores, as long as the dog is under the course time set by the judge for that class. Scores may also be earned in both Standard and JWW from regular standard runs (at the minimum yps required for entry into WTT) or Premier standard runs (no minimum yps as long as the dog is under course time for that class) and regular JWW runs (at the minimum yps required for entry into WTT) or Premier JWW runs (no minimum yps as long as the dog is under course time for that class.)

ISC Combined Class Winners Combined scores from ISC Jumpers and Standard classes at this event will be used to award the Combined ISC Class Award. To be eligible for the Combined ISC Class Award the team must have a minimum of one clean ISC run and a run that has a maximum of 5 course faults (no time faults allowed) for those scores to be used to compute the Combined Score. The Combined Class winners on Monday from the 12, 16, 20 and 24 inch height is invited to attend Team Tryouts. They do not need to fulfill the requirement of the 4/4 scores. The team must also send in all the required information with the fees and the entry form and meet all the other basic eligibility noted in this document (including an approved pedigree). The handler at tryouts must be the same handler that won the combined award.

The International Sweepstakes Class (ISC) is a non-regular class providing the dog and handler an opportunity to demonstrate their advanced training and handling skills on various International Style Standard and Jumpers with Weaves courses. The rules for this class are generally based on international rules. The variety in International Agility course designs is very diverse, so handlers should be prepared to meet the "Challenge of the Day" when competing in the ISC class. The total challenge level may be easier, more difficult, or simply different from what is currently allowed in Excellent / Master Class. Complete rules for the ISC are available from the AKC Website (<http://www.akc.org>).

Eligibility:

This class is open to dogs that are eligible to compete in AKC agility trials.

Jump Heights:

If jumping a height different than AKC height handler must send in a separate entry for their ISC height Small medium large

Dogs may be entered in their regular jump heights, **however**, only those dogs running in the 12", 16" & 20" class that meet the FCI/ISC measuring cutoff (different than regular AKC cutoffs) or any dog entering the 24" jump height will be eligible for the direct invitation to World Team Tryouts. The FCI/ISC cutoffs for those heights are as follows:

- 12" - Small team – shoulder height = 13 3/4" or less (35 cm is the FCI cutoff)
- 16" - Medium team – shoulder height = 16 7/8" or less (43 cm is the FCI cutoff)
- 20" - Intermediate team – shoulder height = 18 7/8" or less (48 cm is the FCI cutoff)
- 24" - Large team – shoulder height = greater than 18 7/8" (greater than 48 cm)

Exhibitors should follow their veterinarian's recommendations to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

Please consult the AKC Regulations for Agility Trials for a complete description and eligibility for entry into these classes. The exhibitor is fully responsible for entering the dog in the correct class(es)/height divisions. Dogs running in a lower height division than they are eligible for will be eliminated.

HEIGHT DIVISIONS

All height divisions will be offered in the Standard classes, Jumpers With Weaves classes T2B and FAST classes. At the handler's option, dogs may be entered in a higher jump height class, except in preferred classes, where dogs must be entered in their measured height division. Dogs running in a lower height division than they are eligible for will be eliminated. The exhibitor is fully responsible for entering the dog in the correct class(es)/height divisions.

Entering For Exhibition Only (FEO)

- For Exhibition Only may be offered at the option of the host club. FEO will allow exhibitors to work with their dog in a trial environment. FEO is only allowed in the Time 2 Beat and FAST classes and all ISC Classes. Participation in FEO is non-qualifying.
- FEO runs are treated as trial entries. The exhibitor must enter the class(es) (T2B and/or FAST) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.
- Dogs may be entered in any level of FAST (Novice, Open, Excellent, Master). If the dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.
- The exhibitor must declare FEO in the ring prior to leading out to the scribe and the judge.

(Note to Trial Secretaries – the above line has been updated to match the regulations. It had said: "The exhibitor must declare FEO in the ring prior to leading out.

NEW 24-INCH CHOICE HEIGHT – EFFECTIVE JANUARY 2, 2018

This new 24 Inch Choice jump height is for dogs entered in the Regular division that measure 22 inches and under ONLY. Dogs that measure over 22 Inches and are required to jump 24 inches will stay in the current 24 Inch height. Dogs measuring over 22 inches are not allowed to enter 24 Inch Choice. Additionally, dogs that measure 22 inches and under at the withers may not be entered in the 24 Inch jump height on or after January 2, 2018. They may only be in the 24 inch Choice jump height. As is previously done with the 26 Inch class, the course times for the 24 Inch Choice will be the same as the 20 Inch height in all classes.

DOG ELIGIBLE TO ENTER

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds are eligible to participate.

If you would like to know the status of your entry prior to the issuance of the judging schedule upon closing, please enclose a self-addressed, stamped envelope or postcard along with your entry. E-mail confirmations will be sent to those listing a legible e-mail address on the entry form.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes.

Dogs that are blind shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate. Puppies under four (4) months of age are strictly prohibited from the trial grounds.

Express mail entries must include the signature waiver allowing them to be left at the secretary's address. Illegible entries will not be processed and will be returned to the exhibitor. Returned checks do not constitute a valid entry and the Trial Secretary will add a \$30.00 collection fee to the amount of each returned check.

WAIT LIST INFORMATION

Briard Club of America is offering a wait list to fill openings created by withdrawn entries after the trial's closing date/time. A maximum of 20 entries will be placed on the club's wait list. All entries, including wait-listed entries, must be received by the Trial Secretary prior to **May 13, 2023** at 10 a.m. Any entries withdrawn after **May 13, 2023** at 10 a.m. will be replaced by a wait listed entry if any are available. If a withdrawn entry is replaced by a wait-listed entry, a full refund will be issued for the withdrawn entry. Any wait-listed entry that does not move off the wait list into the trial by **May 22, 2023** at noon will receive a full refund.

MOVE-UPS

Move-ups for the first trial day must be made in writing (email is fine) by **May 22, 2023** at 6 pm the Monday before the trial. There will be day-to-day move-ups at the show provided the Trial Secretary has received them within 30 minutes after the end of the last class.

A dog which has been entered in Novice "A" class for which it is not eligible to be entered in due to the class restrictions on the dog or the handler may be move to the Novice "B" class under the following conditions: The request for the move must be in writing and presented to the trial secretary at least 30 minutes prior to the start of each trial. The request must state the reason and justification for the move from a Novice "A" class to Novice "B" class.

COURSE WALK-THROUGHS AND WARM-UP INFORMATION

Handlers in all classes are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only. Handlers with multiple dogs, at events with multiple rings may request to walk with a height group other than the one their dog is entered in if a conflict is imminent.

A warm-up area, consisting of a regulation agility jump, may be provided for exhibitors. The warm-up area is to be used exclusively for warming up the dog and not for training or relieving of the dog.

OBSTACLES AND RING CONDITIONS

Obstacles will meet the specifications for obstacles in the current edition of the Regulations for Agility Trials. All classes will take place indoors and has heat/air conditioning on a field turf surface. Ring size will be 95' x 95'

ADDITIONAL SITE INFORMATION

Crating space will be available on a limited basis. The trial site requires a tarp to be placed on the floor underneath your crates. Crates may be left overnight; however, the **Briard Club of America** and the **B&D Creekside Activity Center** will not be responsible for any lost or damaged items left at the show site.

A full service food restaurant and bar is available on the site. There are various restaurants and fast food vendors within a very short driving distance.

Overnight parking will be allowed at the trial site. Electrical hook-ups for motor homes or campers are available.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Trial Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

RIBBONS, AWARDS, AND PRIZES

Ribbons will be awarded in each jump height division in each class as follows:

A New Title ribbon will be awarded to all dog and handler teams finishing a title. A MACH/PACH rosette and decorated MACH/PACH bar will be awarded to all dog and handler teams that attain their MACH/PACH.

NOTICE TO EXHIBITORS

SAFETY, BEHAVIOR and LIABILITY

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The Briard Club of America and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The Briard Club of America reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the Briard Club of America or any official thereof.

All dogs must be on leash at all times when on trial grounds except when in the designated warm-up area or competing on the course.

REFUNDS

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. Refunds or credit will not be issued for less than \$10. A 50% refund will be offered for a positive Covid-19 Cancellation.

Bitches in season are not permitted to compete in Agility Trials. As such, they will receive a refund of the entry fees minus a processing fee of \$10 per day processing fee upon receipt of written certification from a veterinarian submitted on clinic letterhead to the Trial Secretary no later than one half hour prior to the start of the first class of the day of the trial.

Injured or Incapacitated Dogs Briard Club of America will offer credit refunds for dogs for injured or incapacitated after the closing date. Credit refunds will be issued minus a \$10 per class per day processing fee for the injured or incapacitated dog provided written certification from a veterinarian is submitted on clinic letterhead 30 minutes prior to the start of the first day of the trial weekend.

Death of a Dog Briard Club of America will issue a 100% refund in the event a dog's death after the closing date provided written certification from a veterinarian is submitted on clinic letterhead 30 minutes prior to the start of the first day of the trial weekend.

RINGSIDE

Dogs may arrive any time prior to judging if the dog has a valid temporary or permanent jump height card. Otherwise, they must be available for measuring prior to the start of their class if a VMO or AKC Field Rep is available to measure dogs. All dogs not needed for further judging will be excused.

Judges are not required to wait for dogs. The Owner of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

This club agrees to arbitrate claims as set forth on the Official AKC Entry Form for this event.
