From The West:

Take US-22 E. Turn RIGHT onto PA-981 (Go 6.5 Miles). Turn Right onto PA-981/Industrial Blvd. Make FIRST LEFT onto LINCOLN AVE. (Go 0.9 Miles). Turn RIGHT onto CEDAR ST. (CEDAR ST. is 0.1 Miles past CHERRY ST.) (Go 0.1 Miles). Turn LEFT on LIGONIER ST. (Go 0.3 Miles).
