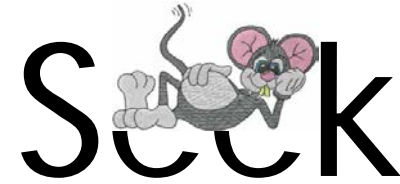

SITE RULES:

Please pick up after your dog and dispose of waste in appropriate containers outside the building.

All dogs must be on a short leash and under control while on trial grounds except while showing.

Parking: In Front of ArcMaster building, sign on building has employee entrance, or on RV side of building. Enter in either of the doors, side door or front door. Front door is facing the parking lot that you drive into from Avenue B or Avenue C.

RUNNING ORDER

Saturday/Sunday: Trial Begins at 9 a.m.

Sat. Ring 1 Four Corners followed by Traditional Hunt

Sat. Ring 2 Chute & Ladder followed by Haystack

Sun Ring 1 Four Corners followed by Traditional

Sun Ring 2 Maze Craze followed by Here, There & Everywhere

AWARDS: Ribbons will be awarded for this trial.

Crating will be available inside.

Blind, deaf and handicapped dogs are eligible to compete.

Bitches in season are not eligible to compete. After the trial closes, entry fees will not be refunded.

DIRECTIONS TO TRIAL SITE

Address for GPS: 500 Avenue B; Latrobe, PA 15650

From The East:

Take I-70/US 30 W. Merge onto PA-982 toward Bradenville (Go 1.0 Miles). Turn LEFT onto LIGONIER ST. (LIGONIER is just past DIANE ST.) (Go 0.3 Miles). Turn LEFT onto AVENUE B. (AVENUE B is just past AVENUE C) (Go 0.3 Miles. 501 AVENUE B is on the RIGHT (Destination is just past WATKINS AVE.) (Go 0.01 Miles)

From The West:

Take US-22 E. Turn RIGHT onto PA-981 (Go 6.5 Miles). Turn Right onto PA-981/Industrial Blvd. Make FIRST LEFT onto LINCOLN AVE. (Go 0.9 Miles). Turn RIGHT onto CEDAR ST. (CEDAR ST. is 0.1 Miles past CHERRY ST.) (Go 0.1 Miles). Turn LEFT on LIGONIER ST. (Go 0.3 Miles). Turn RIGHT onto AVENUE B (AVENUE B is just past AVENUE A) (Go 0.3 Miles). 501 AVENUE B is on the RIGHT (destination is just past WATKINS AVE.) (Go 0.01 Miles).

From the North:

Take I-76 S. (Pennsylvania Turnpike). Merge onto US-30 E. via EXIT 67 toward GREENSBURG (Go 18.9 Miles). Merge onto PA-982 toward Bradenville (Go 1.0 Miles). Turn LEFT onto LIGONIER ST. (LIGONIER ST. is just past DIANE ST.) (Go 0.3 Miles). Turn LEFT onto AVENUE B. (AVENUE B is just past AVENUE C) (Go 0.3 Miles). 501 AVENUE B is on the RIGHT. (Destination is just past WATKINS AVE.) (Go 0.01)

From the South:

Take US-119 N. Merge onto PA-982 toward Bradenville (Go 1.0 Miles). Turn LEFT onto LIGONIER ST. (LIGONIER is just past DIANE ST.) (Go 0.3 Miles). Turn LEFT onto AVENUE B. (AVENUE B is just past AVENUE C) (Go 0.3 Miles. 501 AVENUE B is on the RIGHT (Destination is just past WATKINS AVE.) (Go 0.01 Miles)
