In such case, no refund of any fees paid will be made.

**The Loyalhanna Agility Club** and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children not under the control of their parents or guardians.

**The Loyalhanna Agility Club** reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the **Loyalhanna Agility Club** or any official thereof.

**All dogs must be on leash** at all times when on trial grounds except when in the designated warm-up area or competing in the ring.

**Dogs may arrive** any time prior to judging. All dogs not needed for further judging will be excused.

**Judges are not required** to wait for dogs. The Owner of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

**Extra catalogs** will be available at the Trial for \$5.00.

### ADDITIONAL SITE INFORMATION

**Crating space** will be available on a limited basis. The match site requires a tarp to be placed on the floor underneath your crates. Crates may be left overnight; however, the **Loyalhanna Agility Club** and B&D Creekside Activity Center will not be responsible for any lost or damaged items left at the show site.

**A full service food** is available on the site. There are various restaurants and fast food vendors within a very short driving distance.

**Exhibitors are responsible** for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Trial Committee deems the exhibitor to be in violation of this requirement. 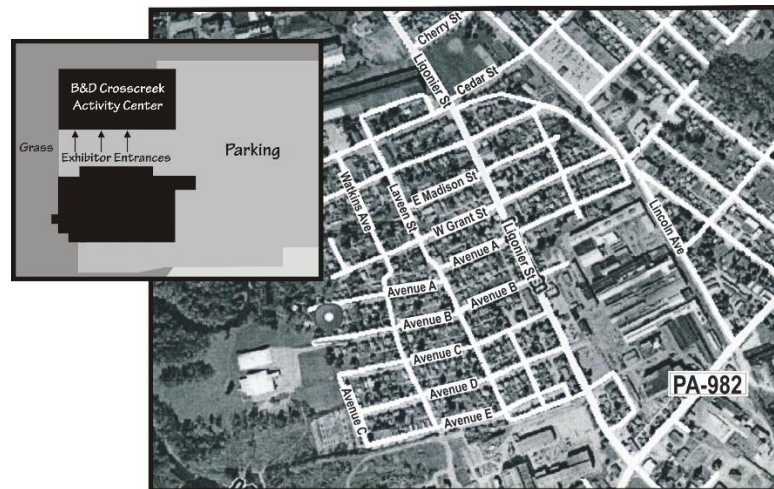

These dogs should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entrants.
