## NEW 24-INCH CHOICE HEIGHT – EFFECTIVE JANUARY 2, 2018

This new 24 Inch Choice jump height is for dogs entered in the Regular division that measure 22 inches and under ONLY. Dogs that measure over 22 Inches and are required to jump 24 inches will stay in the current 24 Inch height. Dogs measuring over 22 inches are not allowed to enter 24 Inch Choice. Additionally, dogs that measure 22 inches and are the withers may not be entered in the 24 Inch jump height on or after January 2, 2018. They may only be in the 24 Inch Choice jump height. As is previously done with the 26 Inch class, the course times for the 24 Inch Choice will be the same as the 20 Inch height in all classes.

## DOG ELIGIBLE TO ENTER

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds are eligible to participate.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes.

Dogs should be physically sound. Dogs that are blind shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate. Puppies under four (4) months of age are strictly prohibited from the trial grounds.

## WAIT LIST INFORMATION

Loyalhanna Agility Club is offering a wait list to fill openings created by withdrawn entries after the trial's closing date/time. A maximum of 20 entries will be placed on the club's wait list. All entries, including wait-listed entries, must be received by the Trial Secretary prior to October 16, 2021 at 10 a.m. Any entries withdrawn after October 16, 2021 at 10 a.m. will be replaced by a wait listed entry if any are available. If a withdrawn entry is replaced by a wait-listed entry, a full refund will be issued for the withdrawn entry. Any wait-listed entry that does not move off the wait list into the trial by October 23, 2021 at noon will receive a full refund.

## MOVE-UPS

Move-ups for the first trial day must be made in writing (email is fine) by October 23, 2021 at 6 pm the Monday before the trial. There will be day-to-day move-ups at the show provided the Trial Secretary has received them within 30 minutes after the end of the last class.

A dog which has been entered in Novice "A" class for which it is not eligible to be entered in due to the class restrictions on the dog or the handler may be move to the Novice "B" class under the following conditions: The request for the move must be in writing and presented to the trial secretary at least 30 minutes prior to the start of each trial. The request must state the reason and justification for the move from a Novice "A" class to Novice "B" class.

## COURSE WALK-THROUGHS AND WARM-UP INFORMATION

Handlers in all classes are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only. Handlers with multiple dogs, at events with multiple rings may request to walk with a height group other than the one their dog is entered in if a conflict is imminent.

A warm-up area, consisting of a regulation agility jump, may be provided for exhibitors. The warm-up area is to be used exclusively for warming up the dog and not for training or relieving of the dog.

## **OBSTACLES AND RING CONDITIONS**

Obstacles will meet the specifications for obstacles in the current edition of the Regulations for Agility Trials. All classes will take place indoors and has heat/air conditioning on a field turf surface. Ring size will be 95' x 95'

#### ADDITIONAL SITE INFORMATION

Crating space will be available on a limited basis. The trial site requires a tarp to be placed on the floor underneath your crates. Crates may be left overnight; however, the Loyalhanna Agility Club and the B & D Creekside Activity Center will not be responsible for any lost or damaged items left at the show site.

A full service food restaurant and bar is available on the site. There are various restaurants and fast food vendors within a very short driving distance.

**Overnight parking** will be allowed at the trial site. Electrical hook-ups for motor homes or campers are available.

**Exhibitors are responsible** for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Trial Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

## NOTICE TO EXHIBITORS

#### SAFETY, BEHAVIOR and LIABILITY

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The Loyalhanna Agility Club and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The Loyalhanna Agility Club reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the Loyalhanna Agility Club or any official thereof.

All dogs must be on leash at all times when on trial grounds except when in the designated warm-up area or competing on the course.

## REFUNDS

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. Refunds or credit will not be issued for less than \$10.

Bitches in season are not permitted to compete in Agility Trials. As such, they will receive a refund of the entry fees minus a processing fee of \$10 per day processing fee upon receipt of written certification from a veterinarian submitted on clinic letterhead to the Trial Secretary no later than one half hour prior to the start of the first class of the day of the trial.

Injured or Incapacitated Dogs LAC will offer credit refunds for dogs for injured or incapacitated after the closing date.

Credit refunds will be issued minus a \$10 per class per day processing fee for the injured or incapacitated dog provided written certification from a veterinarian is submitted on clinic letterhead 30 minutes prior to the start of the first day of the trial weekend.

Death of a Dog LAC will issue a 100% refund in the event a dog's death after the closing date provided written certification from a veterinarian is submitted on clinic letterhead 30 minutes prior to the start of the first day of the trial weekend.

#### RINGSIDE



# **Entering For Exhibition Only (FEO)**

As of January 1, 2020, For Exhibition Only may be offered at the option of the host club. FEO will be offered on a one-year pilot basis in order to give AKC time to evaluate its impact. FEO will allow exhibitors to work with their dogs in a trial environment. FEO is only allowed in the Time 2 Beat and FAST classes. FEO will be of value to new exhibitors or exhibitors that are having difficulty with a specific obstacle and/or ring environment. Competitors must enter in T2B and/or FAST. Participation in FEO is non-qualifying.

- FEO runs are treated as trial entries. The exhibitor must enter the class(es) (T2B and/or FAST) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler will declare the day of the show.
- Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.
- Dogs may be entered in any level of FAST (Novice, Open, Excellent, Master). If the dog is not eligible for the level entered, the team is committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.
- The exhibitor must declare FEO in the ring prior to leading out. FEO may be declared earlier (ex. when checking in at the gate board).
- Toys are allowed in the ring
  - Toys must be non-audible
  - Toys may not leave the handler's hand
  - Toys that roll freely cannot be used
- Food/treats are not allowed in the ring
- FEO should be utilized for the benefit of the dog and not as a punitive correction. Harsh verbal and /or physical corrections shall not be tolerated. Any determination of harshness by the judge shall be immediately whistled and the handler will be dismissed from the ring.
- A judge must monitor the entire run. Judges can stop a run at any time

(Note: This section only needs to be published in the Premium List if the Club is offering FEO.)

# Fix and Go On (FNG)

As of January 1, 2020, Fix and Go On will be offered on a one-year pilot basis in order to give AKC time to evaluate its impact. FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using FNG will result in a nonqualifying score.

Fix and Go On is not pre-entered; rather, it occurs during the course of the run.
