The Loyalhanna Agility Club reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the **Loyalhanna Agility Club** or any official thereof.

All dogs must be on leash at all times when on trial grounds except when in the designated warm-up area or competing in the ring.

Dogs may arrive any time prior to judging. All dogs not needed for further judging will be excused.

Judges are not required to wait for dogs. The Owner of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

Extra catalogs will be available at the Trial for \$5.00.

ADDITIONAL SITE INFORMATION

Crating space will be available. The trial site requires a tarp to be placed on the floor underneath your crates. Crates may be left overnight; however, the **Loyalhanna Agility Club** and B&D Creekside Activity Center will not be responsible for any lost or damaged items left at the show site.

Food will be available on the site. There are various restaurants and fast food vendors within a very short driving distance.

Exhibitors are responsible for cleaning up after their dog(s).
