	Crates may be left overnight, however, WCOTC and the B&D Creekside Activity Center will not be responsible for any lost of damaged items left at the show site. A tarp, mat or plastic must be placed under crates, x-pens, chairs, and food/water bowls.								
	Crating Space is limited. Exhibitors should consolidate their crating area or they might be asked to do so. Ex-pens allower for VERY large dogs or multiple dogs only.

	Exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. For example, the same dog may now be entered in Regular FAST and/or T2B to finish up those titles while also entered in Preferred Master STD/JWW to start working towards their PACH at the lower height. Any mixture of Regular and Preferred classes is allowed.								
	Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.								
	Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.


