*It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and/or children. Any exhibitor whose dog(s) and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may at the discretion of the Trial Committee, be asked to leave the trial site. If an exhibitor is asked to leave the trial site, then the exhibitor will not be refunded any fees that have been paid.

*Entry fees will not be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

Take I-76 S. Merge onto US-30 E via EXIT 67 toward GREENSBURG. Merge onto PA-982 toward Bradenville. At 2nd light, turn LEFT onto LIGONIER ST. Turn LEFT onto AVENUE B. Follow Avenue B to the end, 501 AVENUE B is the white building on the RIGHT.

From the South:

Take US-119 N. Merge onto US-30 E. Merge onto PA-982 toward Bradenville. At 2nd light, turn LEFT onto LIGONIER ST. Turn LEFT onto AVENUE B. Follow Avenue B to the end, 501 AVENUE B is the white building on the RIGHT.

From the East:
