### **Massive sports gambling ring reached IL State Univ.**

Assistant U.S. Attorney Terry Kinney insisted in a court memo Monday that Matthew Namoff, 25, deserves to spend time behind bars. . . .

“Matthew Namoff played an important role in DelGiudice’s illicit business — **as an agent, he ran DelGiudice’s bookmaking operation on a college campus, which facilitated gambling by underage students,**” Kinney wrote.

So far, a February 2020 gambling indictment **that included charges against Mettawa Mayor Casey Urlacher** has only led to prison time for one of the 10 people charged. **Read**

### **Cubs Massive Sportsbook Addition to Wrigley Field**

The Cubs may have torn down the roster recently, but they’re looking to add in a big way to other areas of the organization. . . . they have released plans for **a two-story, 22,350-foot addition to Wrigley Field** at the northwest corner of Addison and Sheffield that would house the nation’s largest individual sportsbook. The plans have been submitted to the City Council and, if approved, the team would aim to complete the construction by the end of 2022.

You may recall that the Cubs **entered into a reported \$100**

**million with DraftKings** last year to bring a sportsbook to Wrigley Field. That money is set to be paid in \$10 million increments over 10 years, a pittance compared to the possible revenue such a venue could take in. [Read Related](#)

### **DraftKings to buy Golden Nugget Online for \$1.56B**

Golden Nugget Online CEO Tilman Fertitta owns 47% of the business, which was formed by spinning off the sports gaming and iGaming operations of the Golden Nugget. The billionaire said he will continue to hold on to the stock of the new company for at least a year after the deal closes. Fertitta will also join the DraftKings board.

#### **The deal gives DraftKings access to Golden Nugget**
