

Gambling Alert - January 21, 2021



Most casinos and video gambling are now open from 8:00 a.m. until 11:00 p.m. in Regions 1, 2, 6, 7, 8, 9, 10).

Video gaming locations in Region 4 (Bond, Clinton, Madison, Monroe, Randolph, St. Clair, and Washington counties) and all licensed gambling operations at DraftKings at Casino Queen and Argosy Casino Alton are still suspended, subject to Tier 3 mitigations. Regions 3 and 5 are in Phase 4, which means Harrah's Metropolis Casino can be open from 8 a.m. to 6 a.m. Read

Casey Urlacher gets pardon in illegal sports gambling case

He <u>was charged last February</u> with conspiracy and running an illegal gambling business. He is accused of acting as an agent for the gambling ring, recruiting bettors in exchange for a cut of their eventual losses.

Prosecutors said in court that Urlacher, who was released on a recognizance bond, faced up to 10 years in prison if convicted of both counts. . . . It is highly unusual for presidents to pardon individuals before they are convicted of a crime. *Read*

Oswego gas station and video gambling

The Oswego Village Board has approved ordinances that will allow a Delta Sonic car wash and gas station under development in the village to apply for a video gambling license.

Carol Latina, who represented residents of Steeplechase in 2017, said she would have appreciated that the area's residents were informed of DeltaSonic's request for a video gambling license prior to it coming to the Village Board for a vote.

She said as "recently as August, I was in communication with the village when I asked for updates" concerning some issues related to the Delta Sonic project, Latina said. "Did no one think or say this is going to be a problem for Steeplechase? I think our history bears that out. Maybe your obligation for transparency ends with the publication of your agenda," Latina said. Read

Beck's "futuristic" Truck Stop with Video Gambling

After resisting for years allowing video gaming in businesses other than bars and restaurants that have a liquor license for on-site consumption, the Washington City Council last year added "truck stops" to the list of places that could offer video gaming. *Read*

NJ to fine sports books asking players to cancel withdrawals

New Jersey's top gambling regulator is threatening to fine sports books operating in his state that ask customers to cancel requests to cash out money from their accounts, saying the practice is ongoing and "unacceptable." **In some cases, sports books have offered to give players cash bonuses if they cancel withdrawal requests,** according to David Rebuck, director of the New Jersey Division of Gaming Enforcement.

Richard Schwartz, president of Rush Street Interactive, which operates PlaySugarhouse.com in New Jersey, said his company approved more than 75% of online player cash-out requests "in real time" during the fourth quarter of last year. Read
