FIRST LEGISLATIVE DAY

JANUARY 17, 2017

This being the first day designated for the convening of the First Session of the Fifty-Third Legislature of the Senate of the State of New Mexico, the members of the Senate assembled in the Senate Chamber in the State Capitol in the City of Santa Fe, New Mexico, on the 17th day of January, 2017, A.D.

The Senate was called to order by the Honorable John A. Sanchez, Lieutenant Governor of the State of New Mexico, at 12:00 p.m.

By unanimous consent, requested by President Pro Tempore Mary Kay Papen "God Bless America" was performed by Orlando Antonio Carillo-Jimenez.

Father Richard W. Murphy delivered the invocation.

The entire body stood for the Pledge of Allegiance to the Flag and Salute to the New Mexico Flag.

The President, Lieutenant Governor John A. Sanchez, appointed Lenore M. Naranjo to serve as temporary Senate Chief Clerk to assist him and to record the proceedings of the convening of the Senate and appointed David Pacheco to serve as temporary Sergeant-at-Arms.
