Write ATTN MAD PIG CUSTOMS on the shipping label if possible. Lead times change due to demand and parts availability. Once your rifle is received, we will inspect it and contact you. We will send you a formal invoice post inspection once we determine if there are any additional issues.

**PAYMENT:** We require a deposit of 60% at time of receipt with the remainder upon completion. If any additional issues or parts are needed that require additional gunsmithing time or parts replacement, you will be contacted before we proceed and it will be added to your final invoice. Gunsmithing is billed at a reduced rate of \$60/hr with a minimum of ½ hour. All prices reflect a 4% cash discount.

Accepted forms of payment: Credit card via phone, paypal, or check. Check's require between 2-5 business days to clear before work begins. Checks should be made out to Mad Pig Customs LLC

- If gun is disassembled, ensure all small parts are in a ziplock-like bag. Mail carriers are notoriously rough with packages.
- Items must be individually padded and not able to move individually inside box (especially rifle barrels).
- Send ONLY the parts that you want coated.
- We recommend insuring the firearm to its full value, and if return shipping insurance is required (recommended) please indicate on order form how much insurance is requested
