Re Variation of Environment Protection Licence No 12559

I refer to your electronic mail dated 18 August 2016 to the Environment Protection Authority (EPA) requesting any additional information requirements for a modified development application seeking construction of a batching plant and an extension to the Blackwood Pit tailings storage facility at Broken Hill Operations Pty Ltd Rasp mine in Broken Hill.

Activities conducted at the Rasp mine are subject to regulation under Environment Protection Licence No 12559 and if approved the proposed modification will require a licence variation prior to the commencement of any construction works associated with the modification.

We have reviewed the information provided and confirm the key issues identified by the EPA for assessment are as follows.

- For the concrete batching plant
 - o a detailed description of the physical operation of the plant;
 - A Noise Impact Assessment identifying cumulative noise impacts associated with the mining operation; and
 - An Air Quality Impact Assessment identifying the cumulative dust impacts and proposed mitigation measures.
- For the extension of Blackwood Pit as a tailings storage facility
 - o a detailed geological impact assessment that defines any risks of failure of the TSF and any potential for pollution to surface waters or ground waters from the proposal; and
 - o An Air Quality Impact Assessment identifying the potential impacts on air quality and proposed air monitoring and mitigation measures.

The assessments must be completed consistent with the EPA's guidelines identified in Attachment 'A'.
