## **PARTICIPATION AGREEMENT**

I acknowledge participation in the 2024-2025 school year involves risk to the student (and to the student's parents/guardians), and may result in various types of injury including, but not limited to, the following: sickness, exposure to infectious/communicable disease, bodily injury, death, emotional injury, personal injury, property damage, and financial damage. In consideration for the opportunity to participate in the 2024-2025 school year, the student (or parent/guardian since the student is a minor) acknowledges and accepts the risks of injury associated with participation in and transportation to and from school. The student (or parent/guardian) accepts personal financial responsibility for any injury or other loss sustained during the 2024-2025 school year or during transportation to and from school, as well as for any medical treatment rendered to the students that is authorized by Sonshine Preschool or its agents, employees, volunteers, or any other representatives (collectively referred to as "school sponsor"). Further, the student (or parent/guardian) releases and promises to indemnify, defend, and hold harmless the school sponsor for any injury arising directly out of participation in school or transportation to and from school, whether such injury arises out of the negligence of the school sponsor, the student, or otherwise.

If a dispute over this agreement or any claim for damages arises, the student (or parent/guardian) agrees to resolve the matter through a mutually alternative dispute resolution process. If the student (or parent/guardian) and the school sponsor cannot agree upon such a process, the dispute will be submitted to a three-member arbitration panel for resolution in accordance with the rules of the American Arbitration Association.
