MISTAKEN IDENTITY

A middle aged woman had a heart attack and was taken to the hospital. While on the operating table she had a near-death experience. During that experience she saw God and asked if this was her time. God said no and explained that she had another 30-40 years to live. Upon her recovery she decided to stay in the hospital and have a face lift, liposuction, and a tummy tuck. She even had someone come in and change her hair color. She figured that since she had another 30 or 40 years, she might as well make the most of it. As she walked out of the hospital after the last operation, she was killed by an ambulance speeding up to the hospital. When she arrived in front of God again, she questioned, "I thought you said I had another 30-40 years?" God replied, "Sorry, I didn't recognize you.

Christmas is the time when we focus on Jesus. He is truly the reason for the season, but often there seems to be some mistaken identity that surrounding Him. Who is Jesus really?

For some people Jesus is always just part of the Christmas vignette. Jesus is the baby in the manger which makes the nativity set complete. He's just a character along with all the other characters that come around at Christmas. Maybe the story of Jesus is just one more Christmas story or the baby just one more one piece in all of the decorations. Many people want to make sure they do Christmas up right. They don't want to leave out any part of the celebration, so if Jesus is part of the Nativity which is part of Christmas, then by all means, let's include Him.

You know Dasher and Dancer and Donner and Blitzen, Frosty and Rudolph, Mary and Joseph, the Grinch, and Macy's and Gimbles and Jesus and Santa.

For some the identity of Jesus becomes just a reason for going to church a couple of times a year. Jesus is someone that is relegated to Christmas and Easter. We aren't really solid on who Jesus is, but we know that special attention is given to Him on at least a couple of occasions. For some Jesus is definitely the reason for the season - all two of them.

Others see Jesus as the Iconic Jesus. Jesus is the picture on the wall in your bedroom or family room, the figure with the hands folded on your shelf, the current screen saver on your computer, or one of the ornaments on your tree. The identity of Jesus is for show and tell. People think more of us when they think we have a spiritual side, so the purpose of Jesus is to help us look and feel spiritual.

Even in His own time, Jesus dealt with mistaken identity. In one conversation Jesus asked his disciples to let him know who others thought He was. The responses were varied. Some say you are John the Baptist. Some say you are Elijah. Some say you are one of the prophets. But it was Peter who correctly answered "You are the Christ - the very Son of God".

That word Christ speaks of the true identity of Jesus. It means that Jesus was the anointed of God. He was the Son of God who came to take His rightful place as prophet, priest and King. He is the anointed Son of God who would offer Himself to die on a cross to take away the sin of the world.

Jesus is God's love in human form. Jesus is the savior of souls destined for Hell. He came not just to be born in a stable, but to die on a cruel cross so that we could have eternal life and fellowship with God our Creator.

He is not just a baby in a manger reserved for Christmas time. He is not a part-time Lord and Savior who is relegated to seasonal worship. Jesus is the true King of Kings and Lord of Lords. He is the One we honor and worship daily. He is the author of life and the One who brings us abundantly each and every day.

This Christmas let us be reminded that Jesus is asking us the same question He asked His disciples. Who do you say I am?

If you say that He is the Christ - the Son of God, then you must decide what you will do with Him. Will you let Him affect your life? Will you give your life over to His control?

John 1:11-12 He came to that which was his own, but his own did not receive him. Yet to all who received him, to those who believed in his name, he gave the right to become children of God—

TRULY HUMAN & TRULY DIVINE : GOD WITH US | APOLOGETIC CORNER

THE MYSTERY AND WONDER OF THE INCARNATION: GOD WITH US

As we enter the Christmas season, we are reminded of the profound mystery at the heart of our Christian faith: the incarnation of Jesus Christ. The Apostles Creed, which we recite regularly in worship, encapsulates this mystery with the words, "He was conceived by the power of the Holy Spirit and born of the Virgin Mary." This statement, though simple, is rich with theological meaning and significance. It reveals the foundations of our faith and the events that changed the course of history.

At Christmas, we celebrate not just the birth of a child, but the birth of the Savior who is both fully God and fully man. The Creed begins by affirming two key truths about Jesus' birth: **Jesus was born of a human mother**, Mary, and **He was conceived by the Holy Spirit**. These truths are based on the biblical accounts found in **Matthew 1:18-25** and **Luke 1:26-38**, and they speak to the heart of **who Jesus is: truly human and truly divine**.

JESUS: TRULY HUMAN

The first part of the Creed emphasizes Jesus' humanity. He was born into the world as we are born—of a woman. He shared our human nature, our joys, and our sorrows. This is crucial to our faith. Jesus' full humanity means that He understands our experiences, our struggles, and our pain. He knows what it means to be human, to face temptation, to suffer, and to die. As the apostle Paul writes in **Galatians 4:4**, "When the time had fully come, God sent his Son, born of a woman." Jesus' birth into the world means that we have a Savior who can identify with us at the deepest level.

JESUS: TRULY DIVINE

But Jesus' humanity is only half of the story. The Creed also affirms that He was "conceived by the power of the Holy Spirit." From the moment of His conception, Jesus was marked out as unique. He is the **Son of God** in every sense. **He did not "become" the Son of God** at a certain moment in His life, as some early Christian heresies claimed. No, **He was always the Son of God**, even from the moment He was conceived in the womb of the Virgin Mary. The virgin birth is essential because it demonstrates that Jesus is not merely a human being like us; He is also fully divine. His divinity was not something added later, but something inherent from the very beginning.

THE IMPORTANCE OF THE INCARNATION

Why does it matter that Jesus is both fully God and fully human? Because **we need a mediator—someone who can represent both God and humanity**. In any broken relationship, reconciliation requires a go-between who can stand in the gap and represent both sides.

As Paul writes in **1 Timothy 2:5**, "There is one God and one mediator between God and men, the man Christ Jesus." Jesus, fully human and fully divine, bridges the gap between God and us. If He were only human, He would need saving, and if only divine, He couldn't relate to us. But because He is both, He is the perfect mediator who restores our relationship with God.

THE MYSTERY OF THE INCARNATION: GOD WITH US

At Christmas, we celebrate the mystery of **God with us**—the eternal Son of God taking on flesh and dwelling among us (**John 1:14**). This is not just a historical event, but the beginning of God's saving work, which reaches its fulfillment in Jesus' death and resurrection, restoring our relationship with God.

As we celebrate Jesus' birth, let's marvel at the wonder of the incarnation—our Savior, fully God and fully human. This truth is the foundation of our faith and the source of our hope, for Jesus understands us, stands in our place, and makes reconciliation with God possible.

May this Christmas season fill you with awe and gratitude for the incredible gift of Emmanuel—God with us.

CIA Cook's Corner

Sweet Potato Casserole Renee Keiper



1 cup milk

2 tbs cornstarch

18 oz can sweet potatoes (drained and mashed)

2 beaten eggs

Cinnamon – a couple of dashes

34 stick margarine

1 ½ cup sugar

Mix milk and cornstarch, add the remaining ingredients. You may need a mixer to get the lumps out. Bake at 400 degrees for 20 - 30 minutes.

Topping:

1 cup crushed cornflakes

½ cup chopped pecans or walnuts

¾ cup margarine

1 cup coconut

½ cup brown sugar

After the margarine is melted add remaining ingredients. Stir until well coated. Spread over sweet potatoes. Bake another 10 minutes.
