## About SCRAM CAM

Welcome to the SCRAM Continuous Alcohol Monitoring (CAM) program—a productive alternative to incarceration. By adhering to court orders, the SCRAM CAM Participant Agreement, and your own self-achievement goals, your SCRAM CAM experience can be as personally beneficial as you allow it to be.

Following are the SCRAM CAM basics for your information:

### **Transdermal Technology**

SCRAM CAM checks for alcohol consumption by detecting and measuring ethanol through your skin's vaporous perspiration

### **Continuous Monitoring**

SCRAM CAM automatically tests for alcohol consumption every 30 minutes around the clock

### **House Arrest**

SCRAM CAM can also monitor your presence/absence in the home during specified time periods

### **Tamper Alerts**

SCRAM CAM detects any attempts to tamper with, obstruct, or remove the bracelet

### **Ongoing Analysis**

SCRAM CAM stores and electronically transmits test results daily for evaluation and agency follow-up

## Getting Started

Once you are ordered to wear SCRAM CAM and the court has issued a SCRAM CAM Referral Directive, you must call Continuous Alcohol Monitoring LLC to arrange for the installation of your SCRAM CAM bracelet within the time given and provide the following:

- Social Security number
- Driver's license or identification card
- Name of judge, county, and court
- Probation officer's name and contact information
- Attorney's name and phone number
- Any court documents pertaining to your case

## Continuous Alcohol Monitoring LLC and You

Continuous Alcohol Monitoring LLC and you both have a role in the SCRAM CAM monitoring process:

### **Continuous Alcohol Monitoring LLC: Installation and Set-Up**

- Before placing the SCRAM CAM bracelet on, a breathalyzer test will be given to ensure no alcohol is present in your system
- Explains and clarifies the SCRAM CAM Participant Agreement before you sign it
- Attaches the SCRAM CAM bracelet to your ankle
- Gives you a base station to plug into a telephone or internet line at home or at work
- Activates the bracelet to enable it to take readings and store and transmit data via the base station to the central monitoring station

### **Continuous Alcohol Monitoring LLC: Client Management and Monitoring**

- Reviews daily reports and promptly notifies authorities of any confirmed noncompliance with court orders
- Performs equipment maintenance, client support, fee collection, and de-installation

### **You: Continuous Accountability**

- Be near the base station at the agreed-upon time to enable data downloads and home confinement verification
- Do not consume alcohol—NONE
- Do not use products that contain alcohol
- Do not tamper with, obstruct, or damage SCRAM CAM equipment

### **You: Other Regulations**

- **Alcohol-Based Product Avoidance:** Do not expose the area around the bracelet to personal, household, or industrial products that contain alcohol
- **Court-Approved Travel:** Plug the portable base station into any phone line or connect to WiFi to download data on schedule while out of town
- **Showering:** Do take showers while wearing the water-resistant bracelet, but do not submerge it (no bathing or swimming) or you will incur the cost of its immediate repair
- **Payments:** Make SCRAM CAM payments on time

## Paying for the SCRAM CAM Program

### **Daily Monitoring Fee**

Daily monitoring fees are \$10 - \$12 per day.

### **Installation Fee**

A one-time installation fee of \$75 will be charged at time of installation.

### **Payment Methods**

All credit cards accepted, bank wire, Bitcoin, Western Union and Moneygram accepted.

### **Payment Schedule**

Various options available.

### **Failure to Pay**

Failure to make timely payments may result in court notification.

### **Payment Plans**

SCRAM Systems participants are invoiced on the first of each month, and payments are due upon receipt. Various options are available for qualified applicants and must be arranged with Continuous Alcohol Monitoring LLC prior to equipment installation.
