

Program Reference Guide

SCRAM ORDER

- Defendant or probationer (client) ordered—pretrial or post-sentencing—to SCRAM electronic monitoring program for:
 - DUI
 - Domestic violence
 - Juvenile
 - Family court/child custody
 - Any instance where alcohol is a contributing or mitigating factor requiring abstinence or monitoring/reporting

SCRAM DIRECTIVE

- Judge/probation officer/case manager signs directive, including start date and length of monitoring
- Orders or requests for monitoring may be faxed or emailed to Continuous Alcohol Monitoring LLC

CLIENT ENROLLMENT AND INSTALLATION

- Client must contact Continuous Alcohol Monitoring LLC for an appointment within 24 hours of receiving the SCRAM order
- Installs are done at our office clients homes, detention centers, correctional facilities, or other agreed upon location.
- Client must provide Continuous Alcohol Monitoring LLC with all pertinent court documentation
- Continuous Alcohol Monitoring LLC shall notify the reporting agency, court, probation officer, or case manager of successful installation or failure to enroll

MONITORING AND REPORTING

- Client must abide by the terms outlined in the SCRAM Participant Agreement
- SCRAM Continuous Alcohol Monitoring (CAM)
 - With its dual technology, each SCRAM CAM bracelet can provide continuous 24/7 alcohol monitoring only or both SCRAM CAM and House Arrest.
 - Noncompliance is reported within 24 hours of the confirmation and includes:
 - Alcohol consumption
 - Use of alcohol-based products
 - Certain environmental alcohol alerts
 - Attempts to tamper with or circumvent the technology
 - Failure to download data as directed by terms of the SCRAM CAM program
 - For optional House Arrest, violation of HA schedule and parameters reported by standard or priority notification as specified by the court or agency
- SCRAM Remote Breath
 - Remote Breath noncompliance is reported by standard or priority notification as specified by the court or agency, and includes:
 - Alcohol consumption with BrAC level
 - Incomplete or missed tests
 - GPS data when the test took place
 - Results of client identification
- SCRAM GPS
 - Reports of GPS noncompliance are customized to meet the needs of the court or agency, and include:
 - Inclusion and exclusion zone violations
 - GPS location data

COURT SUPPORT

- A Continuous Alcohol Monitoring LLC representative is available to appear in court for all violations
- SCRAM CAM technology has been peer reviewed and has met the Frye/Daubert standard

PROGRAM COMPLETION

- Continuous Alcohol Monitoring LLC must receive court- or agency-approved notification of removal
- SCRAM program is deemed successfully completed when client:
 - Completes monitoring period without violation
 - Has all equipment removed by a Continuous Alcohol Monitoring LLC staff member and has satisfied all financial obligations to Continuous Alcohol Monitoring, LLC
- Certificate of Completion as verification for court or supervising agency

COST

- SCRAM is an offender-paid program
- A one-time installation fee of \$75 will be charged at time of install
