This document serves as a binding contract agreement between

_____, hereafter known as "**Comedy Promoter,**" and **Marshelle Woodland**, hereafter known as "**Founder**" of the **\$100,000 "Show Me Funny" Comedy Festival & Mass Participation Guinness World Record attempt in St. Louis, Missouri, the Head Organizer of The Largest Comedy Festivals Collaboration and The Comedy Movement. (The Comedy Movement Members are the first ones contacted for parts in movies, stage plays and any other entertainment projects of the "Founder")**

The "**Comedy Promoter**" desires to **organize a pre-competition and/or audition in his/her own city and state of _____ to collaborate** with the "**Founder**" for her **2022 \$100,000 Comedy Competition/Festival Event(s)** and to have the **opportunity to be one of the 100 Promoters to collaborate with her for future events.**

***This agreement is only for and between the two parties signing it to collaborate for the details in this document. This idea was founded by Marshelle Woodland, also known as Comedian Ms. Woody, and is planned out with the help of Committee Members from her team. The "Comedy Promoter" has to form his/her own committee to help plan his/her own Comedy Competition/Festival Event(s) and seek sponsors if needed. The winner(s) from the "Comedy Promoter" Comedy Competition/Festival Event(s) will be sponsored by the "Comedy Promoter" to include the following:**

- **Registration fees for that winner(s) to be a contestant at the "Founder" Event(s)**
- **Lodging for the duration of the "Show Me Funny" Comedy Festival**
- **Travel cost to attend the event(s) of the "Founder"**
- **Vendor fees for the dates of July 1 and 2, 2022 only**
- **The Annual Membership fees for the Contestant(s) to join The Comedy Movement**

The \$100,000 "SHOW ME FUNNY" COMEDY FESTIVAL dates of June 13-17, 2022 will start in the host city of St. Louis, Missouri for the Preliminary Rounds. The Semi-Final Rounds will be June 20-24, 2022. The Final Rounds will take place on July 1-2, 2022. The \$100,000 "SHOW ME FUNNY" COMEDY FESTIVAL will include a Guinness World Record attempt at the St. Louis Dome Stadium on July 3, 2022. (capacity of up to 70,000) The final rounds location will be held at the St. Louis Convention Center July 1-2, 2022. It will include 300-400 vendor spaces for comedians to do their MEET & GREET and/or sell merchandise and for other businesses to book a space(s) for trade show events. (More of the event details are located on the website)

*** Both parties agree to abide by the following conditions in 2022:**

The **"Comedy Promoter"** is to find a location for the comedy competition/festival event(s) or talent search in his/her city. The **"Comedy Promoter"** event(s) is to be on a date(s) that will work with the **"Founder"** starting date(s) of the first event and **should be notified of that date and location ASAP** after signing this collaboration agreement. The **"Comedy Promoter"** must send the **"Founder"** the festival/competition name and website link or social media link ASAP. The **"Comedy Promoter"** must make sure the **"Founder"** is updated on everything related to his/her event(s) so any needed changes can be made on the **"Founder"** website and marketing information. This includes any issues on websites, promotional items, any media or at the location(s). The **"Comedy Promoter"** and the **"Founder"** can give if they wish to include a pay-it-forward to a worthy cause(s) a percentage of the proceeds raised from their event(s). The percentage of donations are totally up to the individuals. The **"Comedy Promoter"** must notify the **"Founder"** of the organization(s) receiving proceeds from their event(s) if they include an organization(s) to give to. That organization name and/or logo will be added to the **"Comedy Promoter"** advertisement space on the **"Founder"** website(s) and it is up to the **"Founder"** how long that space is to be occupied. All involved must acknowledge the worthy causes they're supporting and/or organization(s) they're donating to at least a week before the start of their event(s).

The **Events of all "Comedy Promoters" collaborating** will be advertised on the **"Founder"** website(s) and will be removed within one year of or for reasons due to the ending of this agreement. The **"Founder"** wants her event(s) to be added to the website and/or social media of the **"Comedy Promoter"** within a week after signing this agreement. If the **"Comedy Promoter"** doesn't have a website that her event(s) can be placed on the **"Comedy Promoter"** must create a social media page if he/she doesn't have one and include the **"Founder"** event(s) in their Event Flyers and other means of advertisement of the **"Comedy Promoter"** event(s) in this collaboration.

The **"Comedy Promoter"** will be charged the fee amount below for the following aspects of his/her event(s) if it runs for 4-6 weeks. The **"Comedy Promoter"** can make a large amount of money from this collaboration from ticket sales, donations, sponsors and/or investors.

The **"Comedy Promoter"** will pay **\$2,500 for each contestant(s)** which covers the winner round trip travel, hotel stay for the whole competition and lock them in as a sponsor for 2022. This \$2,500 fee also **includes our collaboration fee of \$1000.** These fees will go up in the year 2023. The **"Comedy Promoter"** **can pay just \$1,500 for their 2022 contestant if he/she only wants to be a sponsor and/or can't organize the event(s) he/she started when the agreement was signed.** Some of the **fees should be deposited into the account of Midwest Show Me Funny Entertainment within 14 days after the "Comedy Promoter" and "Founder" signs this agreement** and the **balance should be paid no later than one week before the end of the "Comedy Promoter" last event date.** A **\$100 deposit per contestant(s) is due within 2 days of signing this agreement.** This is due so that a spot in the **"Founder" Comedy Festival is locked in for your contestant(s) and/or for taking up 1 or 2 of the 100 spots for Contestants of her event.**

The Contestant will be allowed to sell the merchandise of his/her sponsor and whatever he/she has to sell at the trade show location(s). However, the venue of the **"Show Me Funny" Comedy Festival** has the right to say no to anything that is not allowed to be sold on their premises. It is up to the **"Comedy Promoter"** to find out what is allowed to be sold if they want their winner(s)/contestant(s) to sell something at the vendor event(s). The **"Founder"** will cover the cost to bring a contestant to her event if the **"Comedy Promoter"** drops out of this agreement and if it doesn't cause conflict with any other contestant. Each **"Comedy Promoter"** should know and be allowed to attend any and all meetings related to planning these collaboration events if helping get sponsors. The **"Founder"** must notify all involved at least 8 weeks or **ASAP** of any changes to any of the event(s) related to this Collaboration Agreement. Especially for locations, dates, travel plans, cancellations and anything that may cause any of the **"Comedy Promoters"** a financial hardship.

The **"Comedy Promoter"** and **"Founder"** **WILL NOT** enter into any contract agreements on behalf of either party without their knowledge and consent to do so.
