Funding Opportunities:

Funds Awarded-

- Calhoun County Opioid Settlement Funds- Brandi and Alicia worked together to complete this application. Brandi submitted the grant application on August 7, 2025, for the Recovery Grounds Café- \$115,000. On August 20th, Brandi received notification that we had been approved for a partial award in the amount of \$100,000 which will begin distribution on October 1st. Brandi signed award contract on September 8, 2025.
- BCCF- Mini Grant- Brandi submitted a grant application on August 5, 2025, to purchase literature for the Recovery Grounds Cafe- \$1,500. We received funding for this project (in full) on August 26th. The funds were exhausted in full on September 9, 2025.

- Foundation for Opioid Response Efforts- Dan submitted the grant application requesting \$150,000 (over a 24-month funding period) on July 1st, 2025, for the Recovery Grounds Café Project. We have yet to receive a response for this grant request.
- Scaife Family Foundation- Brandi submitted a grant application requesting \$50,000 on July 3rd, 2025, for the Recovery Grounds Café Project. We have yet to receive a response for this grant request.
- Battle Creek Community Foundation- Competitive Grant. Alicia is working to complete
 this grant application and met with the Battle Creek Community Foundation on
 Wednesday, September 10th to further discuss this opportunity. She will submit the
 completed grant on or before the deadline of October 8th.

Old Business

Opioid Settlement Funding/ Outreach Grant Award Update:

- ➤ Brandi completed and submitted the August FSR report on September 10th, 2025, reporting \$5,649.20 attributed to the grant funding. We have utilized all the funds for this grant cycle and will not receive any further payments from this grant.
- ➤ Brandi will plan to submit the Q4 Report in early October as well as the grant cycle final report by the end of October. We are currently on track with all outcome measures and are fully compliant with the grant requirements.
- Community Workshops
 - We offered our final Opioid Awareness & Narcan Training, facilitated by Nancy King from the COPE Network on Wednesday, August 13th.

o Daniel Schell, Leadership Initiative-

- Executive Director Academy Courses through the Non-Profit Network. Dan received his Certificate of Completion on July 24th, 2025!!! Good job Dan!
- Certified Nonprofit Professional program through the Nonprofit Leadership Alliance. He is on track to complete this certification program in October.
- Recovery Grounds Cafe- Dan and Brandi met with Don Schmidke from Schmidke Builders on September 9, 2025. He has offered to recommend an architect for us to contract. He will also be providing us with a complete quote for the entire renovation. He believes that we will be in the \$200k-\$250k ballpark, which means that we are just over halfway there!

The Board discussed the next phase of this project and have agreed that we will
contract with an architect to provide drawings of the Recovery Grounds Café
project. We plans to complete this contract asap to continue moving forward.

New Business

- New Board Member Nomination- Michael Mann (nominated by Fernando Rosa). After discussion, the Board Members present voted unanimously to welcome Michael Mann to the Board.
- As the Alano Club fiscal year completed on June 30th, Brandi has begun working with Lisa at Stonehenge Accounting to complete our annual tax return. Brandi also reported that the State of Michigan Annual Corporate Report has been completed, submitted and approved by the State
- The ACE Committee reimbursed the Alano Club \$760 for the Tigers/Braves Baseball game. No funds remain outstanding.
- Brandi is suggesting revisions to the ACE Committee Overview- Roles and Responsibilities. After much deliberation, all recommended changes have been approved. This was decided by vote: Approved by Brett S., Scott M., Kyra M., and Brandi C.; Opposed by Fernando R. and Roy T. Mike M. abstained from voting.
