<u>Rubix Technology / Website</u>: Rubix sent us a bill for 2021 – 2022, \$4,068.75, including all the calls made in late 2022 for website work; \$2,000 to be paid by Bryan.

Fernando R. motioned to pay the balance of this bill not paid by Bryan; Brandi C., seconded; Motion passed 4 ayes, 1 abstaining (Jeannie G.).

<u>Bylaws Revision:</u> Jeannie G. had a few new revisions; New version of bylaws passed out, highlighted in yellow with sections that need clarification.

New Business:

ACE Restructuring Committee – need members and new rules; March 30 meeting scheduled with Logan A (Former ACE committee person). Need new accounting rules and regulations, and expectations, esp. with regard to expenses and revenues. Need a Board-Level discussion on what we want financially in terms of information regularly from this group.

The board's intention is to be solutions-based with regard to ACE group; Public comment from ACBC members was received as to how the ACE Committee is important to club members and how we might reduce costs at events by restructuring.

Committee Reports:

ACE Committee – SuperBowl party = break even; 85 people on Recovery Night; Murder mystery gross was over \$1.870.
