

# SHOOTING STAR GOLDENS

## PURCHASE AGREEMENT

The following sale and agreement is made and entered into by and between the following parties and is effective this the \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_\_.

I. NAMES: Shooting Star Goldens (hereby seller), located at 3111 Hendricks Road, Connell, WA.  
And \_\_\_\_\_ (hereby buyer)

Agree to the following terms of the sale and purchase of an English Cream Golden Retriever.  
(here after puppy).

2. PURCHASE PRICE: The purchase price is **\$2,500** A **\$500** deposit is due to hold the puppy, which shall be paid concurrently with the execution of this purchase agreement and shall be applied towards the purchase price of the puppy. Seller shall not hold a puppy for Buyer until the said deposit has been received. Deposits are accepted via VENMO, ( my venmo link can be found on my website) or in some cases a check will be accepted. The remaining **\$2,000** will be due when the puppy is picked up.

3. SHIPPING EXPENSES: In the event the puppy is to be shipped, Buyer shall be responsible for all associated costs. Buyer will come to agreed location on pick-up day and be responsible to accompany the puppy. Seller will provide a vet certificate of which the buyer shall be responsible for all associated cost.

4. BREEDER GAURANTEES: Seller hereby warrants and guarantees that the puppy has had proper care to date. Puppy has received its first shots and has been wormed. Shot records will be furnished at the time of delivery, Buyer agrees to have the puppy examined by a licensed and reputable veterinarian within 72 hours after receipt of the puppy. If the health of the puppy is found to be at risk due to congenial defect (existing at birth), owner shall notify Breeder and provide a written statement from veterinary describing puppy's condition and shall return, at buyers expense, the puppy and papers to seller within three days of the examination. Seller will replace the puppy or refund the money at sellers sole election and discretion, provided the puppy is in the same mentally and physically as when originally purchased. This does not include worms, fleas, mites, cocci, giardia, or other parasites as they are common in dogs and puppies.

B. Breeder is not responsible if puppy contracts a communicable disease after leaving the breeder's possession.

C. Breeder offers a two year guarantee on any puppy found to have a congenital heart disease, as diagnosed by a board certified cardiologist.

D. Breeder offers a two year guarantee on any puppy found to have congenital eye disease, as diagnosed by a board certified veterinary ophthalmologist.

E. Breeder offers a two year hip guarantee on any puppy found to have degenerative joint disease, as diagnosed by two qualified veterinarians, one of whom is selected by the breeder, and confirmed by an OFA evaluation.

F. To be covered by this guarantee, the following conditions are applicable and are preconditions:

1. Puppy must be owned by original owner named on this agreement.

2. In the case of sudden death of puppy, Breeder must receive a written notice of the puppy's death from the owners vet, along with a necropsy report indicating cause of death.

G. In the event of emergence of a hip, heart, or eye disorder as described above, which is severe in nature and which will significantly decrease the quality of life or longevity of the dog, breeder shall, in its sole discretion, either:

1. Replace the dog with one of equivalent quality from a future litter bred by the breeder. OR

2. Refund veterinary expense up to 50% of original purchase price.

5. LIMITATIONS OF GURANTEE: THE FOLLOWING WILL VOID ALL GUARANTEES:

A. buyer permitting puppy to be underfed or over fed at any time.

\* Underfed – Ribs are highly visible

\* Overfed – Dog has no waist when viewed from above. Belly is rounded when viewed from the side.

\* Ideal body condition: Can feel outline of ribs. Dog has waist when viewed from above. Belly is tucked when viewed from the side.

B. Evidence of neglect or abuse.

C. Previous related trauma (broken bones, other injuries)

D. Dog has been bred.

E. Feeding this dog anything other than premium quality dog food for large breed dogs.

F. Evidence of strenuous exercise – for example: no treadmill, no jogging prior to the age of one, no extensive standing on back legs, no extensive retrieving or playing on slippery floors.

6. REGISTRATION OF PUPPY: This puppy is being sold as a pet and companion animal and as such, registration for this puppy is LIMITED as defined by the AMERICAN KENNEL CLUB.

7. SURRENDER OF DOG: Buyer agrees that this puppy will never be surrendered to any humane society, animal rescue group or animal shelter. Seller will accept any dog that is unable to be cared for and shall assume ownership of, possession of, and responsibility for any such animal previously purchased from seller.

8. COST OF RETURNS: Should an animal be purchased under this agreement be returned for any reasons whatsoever, Buyer accepts responsibility for, and shall pay, without recourse against the seller, any and all transport expenses, veterinary charges, crate fees, and transport fees.

9. CANCELLATION: Breeder retains the right, at its sole discretion, to cancel this contract at any time and for any reason prior to the puppy reaching 8 weeks of age. If the breeder opts to cancel this contract, Breeder shall refund buyer's deposit within one week of said cancellation.
