Beautification Report- Jeanne

- DEMCO will not remove the utility boxes at the front of the neighborhood. Due the amount of expense to remove, we will plant flowers around it. In the fall we can put down sod and bushes.
- Jeanne will update the reader board upfront for Labor Day.

Social Media Report-

• Blane was not present to report.

Maintenance-

- Vendor has repaired the fence in the front.
- Jeanne has another bid to replace the fence but understands it cannot be done this year.
- The board decided to wait until after Hurricane season to totally replace fences.
- The ground is still too hard to plant the azaleas of the neighborhood and the water lines will need to be repaired.
- Jeanne said ant killer was bought and volunteers will be putting it around the Lighthouse, around the reader board and where the pampas grass grows in the canal opening.
- Jeanne reported that the Parish has come to Lighthouse Lane multiple times to stake out all the
 lots on the end of Lighthouse Lane. They are trying to prove it was the developer's fault for the
 collapse of the culvert that drains from Lighthouse Lane to the pond. The residents on either
 side of the culvert have informed the board they decided to challenge the parish on their own as
 private residents.

New Business-

- Issues with Magnolia not answering the phone when board members called, and residents was addressed with Sarah. She advised that she would look into it and get with her staff.
- Magnolia will inform residents not to park on servitude areas to allow our vendor to get to areas that need to be maintained.
