Born May 8, 1893, in Marsala, Italy, son of Mr. and Mrs. Peter Pulizzi. Lived 56 years in Rockford, coming here from Italy. Married the former Lucy Fiduccia in Rockford in 1939. Employed as an assembler by Roper Corp. for 35 years, retiring in 1960. Member of St. Anthony Catholic Church, and of St. Francis DePaul Society. Survivors include: his widow; one daughter, Mrs. Frank Gardona, Rockford; two sons, Peter, Santa Ana, Calif., and Bernard C., in Viet Nam; one sister, and four brothers in Italy; seven grandchildren, and numerous nieces and nephews.
