# Requirement for public comment on Safe Return Plans 5-1-23

As part of a public school district's receiving American Rescue Plan Elementary and Secondary School Emergency Relief (ARP ESSER) funding, the district is required to take public comment on its Safe Return plan at least every six months. The department will send out DocuSign assurances later in May for districts to assure that they have met that requirement since December 2022. **Assurances will be due June 16.** If you have not already gathered public input on your plan this semester, May or June board meetings would be a great time to accomplish that. Questions regarding the requirement can be directed to <u>Laura Scheibe</u>. Please note that this assurance is required every six months through September 2024 (the life of the ARP/ESSER funds).
