Updates were provided on the following: Locker room construction, Pay Request #8, negotiations, elementary locker quotes comparing 15" to 18", a library carpet quote from Carpets Plus, and the snow makeup day scheduled for May 9, 2025. Prairie Bible VBS has requested the use of a minibus from June 2-6, 2025. The terms will remain the same as in previous years. On May 1, 2025, the Art Show will have the standard admission prices. There was also a discussion regarding a potential opt-out, including the need and steps involved.

Each succeeding Participation Agreement changing in any manner benefits, contributions, or obligations arising under the Workers' Compensations Fund shall be submitted to the Board for approval prior to execution by the Superintendent and Business manager.

It is further moved and resolved that coverage provided in the ASB Worker's compensation Fund Participation Agreement shall extend from 12:01 a.m. CST, July 1, 2025, to 12 midnight CST, June 30, 2026. The projected contribution required for such coverage as provided in the ASB Workers' Compensation Fund participation Agreement is \$11,700.00.

There is hereby delegated to the Superintendent and authority to carry out, or to further delegated subject to his supervision and responsibility, the obligations of the District identified in the Bylaws approved herein, the Participation Agreement, and Master Contracts provided by the Trust Administrator. Finally, the Board hereby agrees to indemnify the Trust and its members, pursuant to the process established in the bylaws approved herein, the full amount of any assessment levied by the Trust Board pursuant to the Bylaws and the full amount of any contributions agreed to in the current or subsequent Participation Agreements approved by the Board as submitted upon proper vouchers.
