Valley drain would be installed by Gray Construction if board decides on would work. The 10<sup>th</sup> grade computers have been given to students. The 25 chromebooks are not in yet. The server went down on September 4<sup>th</sup>, Expect was here that day. A server has been ordered. COVID 19 1 student has been diagnosed. The plan is not to go remote learning every time a positive case in school. The factors of state fair, homecoming, first week of school, age of the kids, siblings, first case, and a Friday all were considered with remote learning. Three families have been close contact. The school will not

The school has advertised for a para and part time janitor. The playground is up and running. Thank you to the awesome work done by volunteers for install!! Angela R, Ashley H, Heather R, Louie N, Dwight N, Pat S, Tommy W, Ried M, Matt M, Brade R, Brandon W, Allan R, Dave B, Kevin T, Craig H, Josh U, and Jim W. Fence around the playground quote from Voiska Fencing with 2 gate and walkthrough gate. The school needs two more pieces of plastic edging. Would you like us to use the old cement from the old building as edging on the basketball court? Wood floor update- October 2, November 2, or next summer. The board would like booked next summer. The school has not been charging for admission due to the pandemic. The storage shed will be rented for September for sure and probably October. School Pictures were talked about and no contract currently. Digital Solutions from Norfolk, NE will be taking pictures this year.

Mr. Wieseler talked about the successful learning of the 5<sup>th</sup> and 6<sup>th</sup> grade class on line. Reminder that attendance awards, incentives, and etc. are suspended this year. Elementary teachers and students are adapting to changes and handling it well. Much of the k-6 beginning of the year testing is complete. (STAR Reading, STAR Math, and DIBELS testing) The student began using the playground today. All that is left to add is the fence, grass for the field, and the GAGA Ball pit. Mr. Wieseler also gave date of interest to the board.

The current enrollment for this school year is Doland attendance Center 89, Clark Elementary 13, Hillside Elementary 20, Hillside High School 6, Camrose Elementary 10 for a total of 138. The fall 2021 is projected to be 146. The fall 2022 is projected to be 143.

Mr. Hulscher spoke on the building project and the playground project. He show the board the quote from Voiska Fencing in Aberdeen. Mr. Hulscher was given another company to contact for quote.

Action 21-175: Motion by Schneider, 2<sup>nd</sup> by Hansen, to accept the Doland Education Association as the bargaining unit for the 2020-2021 school year. Mrs. Melissa Knox and Mrs. Bailey Coats will be the negotiators for the Doland Education Association (DEA). All ayes.

Action 21-176: Motion by Moes, 2<sup>nd</sup> by Schneider, to disclose the Doland School District is a member of the Iroquois Doland Athletic Cooperative, a member of the North Central Special Education Cooperative, a member of the Title III Consortium, and the Great Lake Consortium for Perkins grants. All ayes.

Action 21-177: Motion by Schneider, 2<sup>nd</sup> by Hansen, to pay for flu shot for all staff even if not on in the Northern Plains Insurance Pool. All ayes.

Action 21-178: Motion by Felderman, 2<sup>nd</sup> by Hansen, to appoint Julie Schneider for the delegate for ASBSD for the 2020-2021 year. All ayes.

A discussion on the current 2020-2021 budget was held. The new restrictions on capital outlay funds, the funding cap for general fund, pension fund will be going away, the flexibility of only new money in the capital outlay fund to be moved to general fund, and other revenue funding will be equalized.

Action 21-179: Motion by Hansen to adopt the *Resolution No. 3, Adoption of the annual budget, Let it be resolved,* that the school board of the Doland School District, after duly considering the proposed budget and its changes thereto, to be published in accordance with SDCL 13-11-2 hereby approves and

adopts its proposed budget and changes thereto, to be its Annual Budget for the fiscal year July 1, 2020, through June 30, 2021. The adopted annual budget levy request are as follows: general fund 1.443 per \$1,000.00 of ag land, oo (owner occupied) \$3.229 per \$1,000.00, oth (other) \$6.692 per \$1,000.00 which is maximum requested, opt out of \$227,000.00; Special Education Fund of \$.100 per \$1,000.00 of total valuation; Captial Outlay of \$513,400.00 or maximum amount. Second by Schneider. All ayes.

Action 21-180: Motion by Hansen, 2<sup>nd</sup> by Felderman, to accept and approve open enrollment forms from OE-21-001 and OE-21-002 for the 2020-2021 school year. All ayes.

Action 21-181: Motion by Schneider, 2<sup>nd</sup> by Hansen, to declare the items from special education and library as surplus property. The items are no longer useful and will be properly disposed of by the school. The list of items is on file in the business office. All ayes.

The board of give a sample of dual library papers. The Doland School will review the dual library papers.

Action 21-182: Motion by Moes, 2<sup>nd</sup> by Hansen, to accept the following donations from Duane and Phyllis Divich for the playground, Bonnie Wagner for student and adult masks, and James Valley Telecommunications for donation to help the students. The board of education signed "thank you's" for the donations. All ayes.

Mrs. Lewis spoke on the employment tax directive "tax holiday.

The State will be issuing Coronavirus Relief Fund payment in September and November by student count.

Action 21-183: **Resolution Number 4** Motion by Felderman, to ensure continuity of operations of essential functions, the Doland School District designates all employees as critical infrastructure workers for the duration of COVID 19 pandemic. The Doland School District does not have available the necessary substitutes teachers in sufficient numbers, nor the necessary personnel to fill the absent staff members, to the school system operation. The CDC advises that critical infrastructure workers may be permitted to continue work following potential exposure to COVID 19, provided they remain asymptomatic and additional precautions are implemented to protect them and the community.

A potential exposure means being a household contact or having close contact within 6 feet of an individual with confirmed or suspected COVID 19. The timeframe for having contact with an individual includes the period of time of 48 hours before the individual became symptomatic. Critical infrastructure workers who have been an exposure but remain asymptomatic will adhere to the following practices prior to and during their work shift:

- Pre-Screen: A staff member will measure the employee's temperature and assess symptoms prior to them starting work.
- Regular monitoring: As long as the employee doesn't have a fever or symptoms, they should self-monitor under the supervision of their employer's occupational health program.
- Wear a mask: The employee will wear a face mask at all times while in the workplace for 14 days after the last exposure.
- Social Distance: The employee should maintain 6 feet and practice social distancing as work duties permit in the workplace.
- Disinfect and clean work space: All work areas such as offices, bathrooms, common areas, and shared equipment will be cleaned routinely. Schneider, 2<sup>nd</sup> resolution. All ayes.

The Doland School is not eligible for the free lunches under the SSO until December 31, 2020. The school district must met one of the three ways of eligibility. The Doland School mets none of these under the USDA guidelines.

Action 21-184: Motion by Hansen, 2<sup>nd</sup> by Schneider, to go into executive session at 8:31 p.m. for personnel per SDCL 1-23-2 (1). All ayes.

Chairperson Noethlich declared executive session over and reconvened into regular session at 8:34 p.m.

The next regular scheduled board meeting will be on October 12, 2020, at 8:00 p.m., more than likely in the lunchroom for social distancing.
