

## **Policy Statement General Data Protection Regulation**

## SHEWoolf Commitment:

When it comes to processing personal information as a Data Controller and Data Processor for our own and our stakeholder's data, for the consultancy and training services we deliver, we will process only very limited personal data. There are core principles we always follow:

- Purpose limitation
- Data storage minimisation / limitation
- Confidentiality, integrity and accountability

These principles assist SHEWoolf to ensure that personal information is processed in accordance with privacy and data protection laws, our policy, and our SAFETY in the Pack values of support, assistance, foresight, engagement, transformation and yielding. The data we collect, and process is needed if you make use of our consultancy and training services; you are a client and / or a visitor. We are responsible for deciding how we hold and use personal information about you. We are required under data protection legislation to notify you of the information contained in our privacy notice which sets out the personal data we collect and manage when you interact with our services.

The personal data that is used is limited to the information we need and is processed mainly under the contracted agreements with you to provide the services we have agreed or the tasks you have requested or as needed for legal requirements. There will be instances where we will process information using our legitimate interests for occasional marketing, keep you informed, grow our business and promote good practice in the industry.

We will seek consent, where needed, for the processing of data where the processing activity is not part of the agreed services or for the use of additional personal information in case studies or testimonials. Any processing activities we undertake are fully compliant with UK and European data protection regulations and the Privacy of Electronic Commutations Regulation where needed for the marketing or promotional approaches we may undertake.

We reserve the right to update this Policy at any time, and we will provide you with a new Policy when we make any substantial updates. We may also notify you in other ways from time to time about the processing of your personal information.
