- store your contact details on its databases for the purpose of contacting you if necessary


The University of Kent will process the photograph/recording and your contact details and any related personal data in accordance with the Data Protection Privacy Notice included on the back.

### **RESEARCH PRIVACY NOTICE**

# **HOW LONG DATA IS STORED**

# YOUR RIGHTS AND COMPLAINT PROCESSES

Your rights to access, change or move your information are limited, as we need to manage your information in specific ways in order for the research to be reliable and accurate. If you withdraw from the study, we will keep the information about you that we have already obtained. To safeguard your rights, we will use the minimum personal information possible. If you are not satisfied with our response or believe, we are processing your personal data in an unlawful manner you can complain to the Information Commissioner's Office (ICO).
