# **GDPR Privacy**

#### **Legal Basis for Processing Personal Data under GDPR**

We may process Personal Data under the following conditions:

- **Consent:** You have given Your consent for processing Personal Data for one or more specific purposes.
- **Performance of a contract:** Provision of Personal Data is necessary for the performance of an agreement with you or for any pre-contractual obligations thereof.
- **Legal obligations:** Processing Personal Data is necessary for compliance with a legal obligation to which the Company is subject.
- **Vital interests:** Processing Personal Data is necessary to protect your vital interests or that of another natural person.
- **Public interests:** Processing Personal Data is related to a task that is carried out in the public interest or the exercise of official authority vested in the Company.
- **Legitimate interests:** Processing Personal Data is necessary for legitimate interests pursued by the Company.

In any case, the Company will gladly help to clarify the specific legal basis that applies to the processing, and in particular, whether the provision of Personal Data is a statutory or contractual requirement or a condition necessary to enter into a contract.

## Your Rights under the GDPR

The Company undertakes to respect the confidentiality of your Personal Data and to guarantee your ability to exercise your rights.

You have the right under this Privacy Policy, and by law, if you are within the EU, to:

- Request access to your Personal Data. The right to access, update or delete the information we obtain about you. Whenever made possible, you can access, update, or request the deletion of your Personal Data directly within your account settings section. - Request correction of the Personal Data that we hold about you. You have the right to have any incomplete or inaccurate information we hold about you corrected.
- Object to processing your Personal Data. This right exists where we are relying on legitimate interest as the legal basis for our processing, and there is something about your particular situation, which makes you want to object to our processing of your Personal Data. You also have the right to object where we process your Personal Data for direct marketing purposes.

- Request erasure of your Personal Data. You have the right to ask us to delete or remove Personal Data when there is no good reason for us to continue processing it.
- Request the transfer of your Personal Data. We will provide to you, or a third party of
  your choosing, your Personal Data in a structured, commonly used, machine-readable
  format. Please note that this right only applies to automated information, which you
  initially provided consent for us to use or where we used the information to perform a
  contract with you.
- **Withdraw your consent.** You have the right to withdraw your consent on using your Personal Data. If you withdraw your consent, we may not be able to provide you with access to certain specific functionalities of the Service.

## **Exercising of Your GDPR Data Protection Rights**

You may exercise your rights of access, rectification, cancellation, and opposition by contacting us. Please note that we may ask you to verify your identity before responding to such requests. If you make a request, we will try our best to respond to you as soon as possible.

You have the right to complain to a Data Protection Authority about our collection and use of your Personal Data. If you are in the European Economic Area (EEA) and need more information, please contact your local data protection authority in the EEA.

# **CCPA Privacy**

# Your Rights under the CCPA

Under this Privacy Policy, and by law if you are a resident of California, you have the following rights:

**The right to notice.** You must be adequately notified of the categories in which Personal Data is collected and the purposes for which the Personal Data is used.

**The right to access / the right to request.** CCPA permits you to request and obtain information regarding the disclosure of Personal Data collected in the past 12 months by the Company or its subsidiaries to a third-party for their direct marketing purposes.

The right to say no to the sale of Personal Data. You also have the right to ask the Company not to sell your Personal Data to third parties. **The right to delete Personal Data.** You have the right to request the deletion of Personal Data collected in the past 12 months.

**The right not to face discrimination.** You have the right not to face discrimination for exercising any of your consumer rights, including but not limited to:

- Denying goods or services to you,
- Charging different prices or rates for goods or services, including the use of discounts or other benefits or imposing penalties,
- o Providing a different level or quality of goods or services to you,
- Suggesting that you will receive a different price or rate for goods or services or a different level or quality of products or services.

## **Exercising Your CCPA Data Protection Rights**
