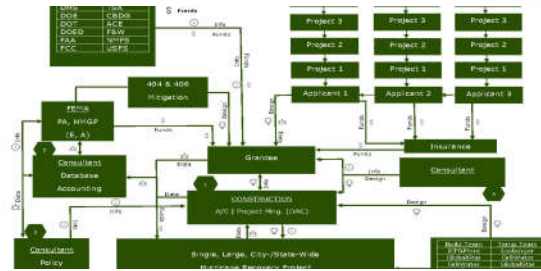
SBA Disaster Loans

PACE: Clean Energy Funding

- ◇ PACE is voluntary for all parties
- ◇ PACE may cover 100% of a projects hard and soft costs
- ◇ Long-term financing; up to 20 years
- ◇ May be combined with utility, local and federal incentives
- ◇ Projects are permanently affixed to the property, not the owner
