### Confirm you're qualified and apply for Pre-Approval

#### You can:

Receive Pre-Approval for a PSE rebate covering up to \$1,000 per unit when replacing current electric resistance heating with code-exceeding, AHRI Certified® packaged terminal heat pumps (PTHP). This rebate requires pre-approval prior to installation.

#### Pre-existing equipment requirements

- Current PSE commercial electric customer in the hospitality-lodging industry, (see pse.com/pthp for details).
  - Replace pre-existing unitary HVAC systems that use electric resistance heating.
  - » Pre-existing PTAC (packaged terminal air conditioners) qualify for replacement.
- » Pre-existing PTHP do not qualify for replacement.
- PSE requires photo proof of pre-existing equipment nameplates prior to new PTHP installation; see additional details at pse.com/pthp.
- New Construction projects are not eligible for this rebate.

#### Qualifying equipment requirements

- Purchase and install a new AHRI Certified PTHP that exceeds WA State Energy Code by a minimum of 10%.
- » AHRI Certificates can be found at https://www.ahridirectory.org/Search/SearchHome
- To determine eligibility of proposed PTHP, the AHRI Certificate data must be at or above the data points in the table below for the proposed PTHP BTU capacity.

| PTHP efficiency requirements = 10% above WA state energy code |        |                |         |
|---|--------|----------------|---------|
| Capacity in BTU   | <8,000 | 8,000 - 10,999 | 11,000+ |
| Cooling - Minimum EER   | 10.2   | 9.8            | 9.1     |
| Heating - Minimum COP   | 3.0    | 2.9            | 2.8     |

#### Incentive qualifications

- PSE's rebate has a not-to-exceed rebate cap of \$1,000 per PTHP unit.
  - PSE's rebate can never be more than the customer paid for the PTHP unit and does not include installation, labor, or taxes.
- » Example 1: PTHP unit cost is \$925; PSE Rebate is \$925, rebate cannot exceed the cost of the PTHP.
- » Example 2: PTHP unit cost is \$1,200; PSE Rebate is \$1,000, rebate is capped at \$1,000 per PTHP.
- PSE requires Invoicing showing the line itemed costs in order to pre-approve PSE rebate amount.\*
