Governor's Challenge to Prevent Suicide Among Service Members, Veterans and their Families (SMVF)



The Challenge

Through its Governor's and Mayor's Challenges, SAMHSA and the U.S. Department of Veterans Affairs support the implementation of a public health approach for the prevention of suicide among service members, veterans, and their families. These efforts help states and communities develop the capacity to implement interagency military/civilian action plans grounded in evidence-based suicide prevention practices.

Partnership

SAMHSA has partnered with the U. S. Department of Veterans Affairs (VA) to bring the Governor's and Mayor's Challenges to Prevent Suicide Among SMVF to states, territories, and communities across the nation. Fifty-two states and territories are currently taking part in the challenge and are working to develop and implement state-wide suicide prevention best practices for SMVF, using a public health approach. SAMHSA's SMVF TA Center is providing technical assistance for these initiatives.

Challenge Objectives

- Engage with Indiana communities and state stakeholders to create, enhance, and align suicide prevention efforts.
- Understand the issues surrounding suicide prevention for SMVF-CG.
- Increase knowledge about implementing best policies and best practices by facilitating community-to-community sharing.
- Introduce evidence-based practices of prevention, intervention, and post-vention to increase awareness and action at the community level.
- Define and measure success, including assignments, deadlines, and measurable outcomes to be reported.

Our Vision & Mission

The Vision:

To Inspire, Empower and Invest in Indiana's community efforts to prevent suicide.

The Mission:

Provide knowledge, choice and support for community coalitions, agencies, and organizations to identify service members, veterans, family members, and caregivers. Foster connection for all communities and provide education, services and resources.

The Logo:

Our logo is an invitation to **JOIN** Indiana's efforts to eliminate suicide among service members, veterans and their family members.

The creation of a new logo represents all the partners and contributors of our mission with a single unified symbol. No one organization or agency is represented by a logo or name.



The three horizontal bars represent the three priority areas of the Governor's Challenge and are washed in the state colors of Indiana.

The bars encompass our state and flow beyond the borders, representing our dedication to go above and beyond, and our affirmation that we must be united as a nation to achieve the mission.

The Indiana Approach

The Indiana plan is based on partnership and participation across Indiana's strong communities. The plan empowers community-led coalitions and Indiana's thriving nonprofit organizations to stand side by side with state agency partners to help prevent suicide among Indiana's service members, veterans, families, and caregivers (SMVF-CG).

Indiana Community Approach

Indiana's communities are as diverse as the state's landscape. From forests to farmland to urban centers, these unique communities understand that locally envisioned, locally led, and fiscally supported initiatives live longer and prosper. Community coalitions and nonprofit organizations of all sizes drive change. This plan fuels these drivers. The Indiana Department of Veterans Affairs (IDVA) and our state partners embrace a tradition of collaboration with local governments and community organizations. The Indiana plan is built upon this foundation with an approach rooted in community-driven activities, local knowledge, and beliefs. We are focused on empowering community coalitions to drive the Indiana Governor's Challenge (IGC) initiatives based on choice, data, resources, and funding.

Funding Approach

The Indiana plan provides both planning and implementation grant opportunities for community coalitions. This process offers the community the introduction to many of Indiana's nonprofit organizations as resources and brings community-led coalition efforts to the nonprofits. Coalitions have the opportunity to consider nonprofits while planning and may utilize their expertise as resources for implementation. The plan will provide grant opportunities to Indiana nonprofit organizations for community programs addressing the priorities of the Indiana Governor's Challenge. These nonprofits will participate in community coalition activities, further connecting them to communities while presenting greater community choice and reach.

IDVA has established experience providing grants that help change veterans' lives. The successes of the IDVA grants program have directly impacted the Indiana veteran community and empowered nonprofits to adapt and reach previously unreachable veteran populations. This experience and success make the IDVA grants team prepared to implement this grant program.

Organized Approach

The combining of programs, resources, and data from the coalitions and their nonprofit partners directly benefits their common audience, SMVF-CG. The Indiana Governor's Challenge team will be the central hub for community coalition grant activities, program organization, data management, data analysis, and coordination through all involved parties. The Indiana team, through process management and program funding, can help provide funding and training to access the necessary tools, techniques, and technologies essential for advancing the community coalition's plans and vision.

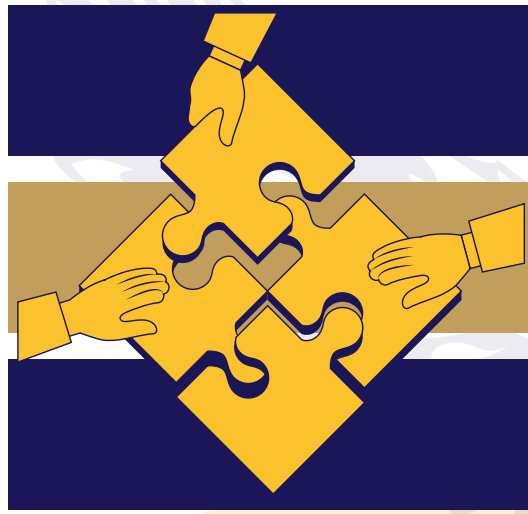

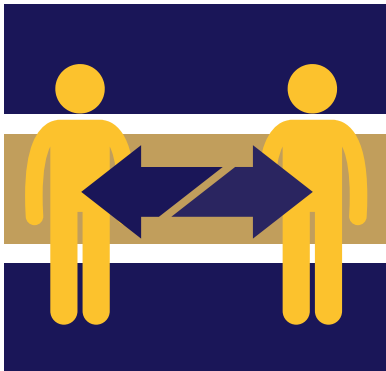

ASK THE QUESTION

PRIORITY GROUP ONE - Identifying SMVF-CG

The first phase is to identify Indiana's SMVF-CG. IDVA is implementing a Short Message Service (SMS) to help identify and capture key data. We offer each coalition the opportunity to acquire an SMS short code to allow the tracking of attendance at events, establish memberships in connection groups, and communicate vital information. The system will provide real-time data allowing for measurable activities and nimble adjustments. Coalitions will have the ability to share SMS trends and comms with IDVA's SMS and veteran status confirmation tool.

Coalitions and partner organizations will have opportunities to dive deeper into the Ask the Question program and military culture training.



PRIORITY GROUP TWO - Creating Connection

SMVF-CG needs to connect, which can come in many ways and from many opportunities. The aim is to provide data, resources, and a collaborative platform that allows for a specific direction determined by the coalition. Our community partners know their communities, know their abilities, and know their needs. The IGC plan is designed to provide guidance and support to assist in their choices. The Indiana team provides detailed options, effective resources and the financial and operational support to achieve success.



PRIORITY GROUP THREE - Lethal Means Storage, Safety, Planning & Training

Safe and responsible firearm usage and storage are imperative. Community education is best provided by members of that community. The goal is to provide SMVF-CG with safe storage options and safety planning, based on quality, community-led education. Coalitions can be advocates to bring two key community partners together: the local mental health community and the local gun community. These partners are critical in being part of creating a local and unified message. The coalitions can utilize the IGC resources to enable the dissemination of their messages how it best works for them.

Coalition Implementation Rollout Priority One - Ask the Question

Coalitions Identifying their SMVF-CG Community

Identifying, communicating with, and gathering feedback from SMVF-CG is essential to effective suicide prevention. Coalitions can combine their knowledge of the local community with IGC implementation funds to develop a strategic communications campaign. Coalitions will be encouraged to explore effective tools such as SMS text communications.

 - The text message sent generates data, communication, and connection
 - The sender becomes integrated into the coalition communication system
 - Effectively measuring:
 - Events - Connection groups - training & education attendance and participation
 - Connection group organizers can communicate directly with their group
- Creates real-time measurable data for coalitions

 - Total number of partner locations
 - Priority 2 and Priority 3 event and group attendance recorded
 - Group communication and response recorded

IDVA Short Message System (SMS)

The IDVA is engaging with the Indiana Veteran Community (IVC) with text message communications via SMS. This system allows for identifying the IVC and direct 2-way communications. Text messages generate data, communication, and connection. Senders become integrated into all IDVA systems and all subsequent scans are logged, creating real-time measurable data. integrated into all IDVA systems and all subsequent scans are logged, creating real-time measurable data. Text messaging provides the opportunity for surveys and wellness assessments, direct response text journeys, and links to services and VA wellness apps.

As the SMS system develops partner organizations IDVA offers them an opportunity for a deeper dive into military culture training.

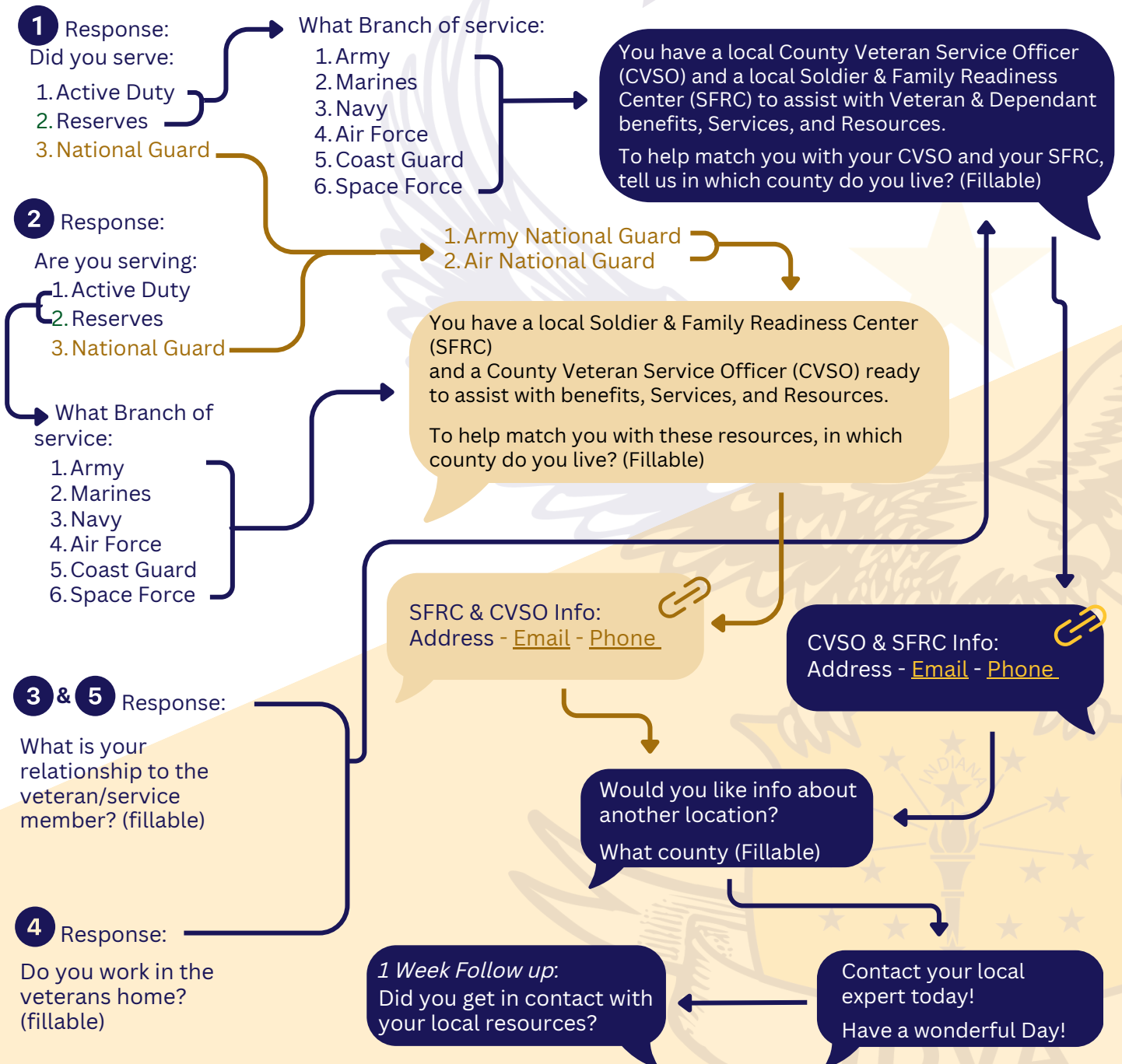

Strategic Planning

Strategic Planning - A full-scale community plan

- The IGC Rollout leaves the coalition to begin strategic planning
 - This strategic planning opportunity for a big-picture plan to address their identified community goals
- Coalitions are encouraged to utilize strategic a planning consultant
- A strategic planning consultant can ensure that ideas and goals are reflected in the strategic plan
- A strategic planner can assist the coalition with:
 - Time
 - Structure
 - Long-term mapping
 - Funding procurement
 - Organizing meetings, notes, plans, and process
 - Creating timelines
 - Specific and measurable goals
 - Standard data collection methods
 - Standard measurability process
 - Projected costing
 - Process flow
 - Expenditure and data reporting process
 - Preparation based on reporting and measurables
- Coalition member's time is precious, strategic planning consultants can expedite planning
- The IGC will work with the coalition's strategic planning consultant
 - Understand the IGC Implementation Grant process

- The coalition applications are solicited for programs and funding that can grow to exist on their own
- The funding is to provide a seed for a community's vision and ensure the start of their long-term vision

Resources and Programs at the Ready

- Coalitions can utilize Indiana nonprofits addressing priority 1, 2, and 3 initiatives with Implementation Grant funding
 - Nonprofits can be introduced to coalitions during the planning grant process

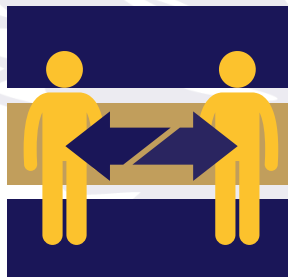
Data Collection and Program Analysis

IDVA will evaluate activities, data, and outcomes of the IGC. Developing a process to evaluate the activities funded by the planning and implementation grant and measure the effectiveness of the IGC programmatic activities and initiatives.

- This evaluation will include both process and outcome evaluation metrics that show the success of the IGC program, coalition implementations, and the impact of local and state-wide programs.

The IGC will work with coalitions to develop strategic plan success monitoring and evaluation.

As grant funds are obligated, IDVA will develop a data-reporting schedule for the coalitions to meet all GVS evaluation and reporting requirements.
