### Phase 1: Bid Review & Prequalification

1. Review Solicitation – Identify contract type and compliance requirements.
2. Extract and Analyze Bid Documents – Organize RFQ/RFP documents, cross-reference embedded PDFs.
3. Project Charter Creation – PMBOK-aligned charter in Iecusoft™ CRM & Workflow System.

### Trauma-Informed Guard Training: CALM, SAVE, and ASIST

All Iecusoft™ guards assigned to VA facilities are required to complete specialized training in suicide awareness, trauma-informed care, and empathetic intervention techniques, including:

- CALM (Counseling on Access to Lethal Means)
- SAVE (Signs, Ask, Validate, Encourage & Expedite)
- ASIST (Applied Suicide Intervention Skills Training)

These evidence-based protocols are endorsed by the Department of Veterans Affairs, SAMHSA, and the Suicide Prevention Resource Center, and are specifically developed to equip non-clinical personnel to recognize early indicators of crisis, engage veterans appropriately, and escalate intervention quickly and professionally.

Security personnel are trained not simply to observe, but to serve as the first and last line of silent support for a veteran walking into a VA facility — whether for an appointment, a difficult diagnosis, or a final cry for help.

Every hour of training is tracked in our AI-powered compliance system, accessible via our live ERP platform, and fully auditable in real time by the Contracting Officer.

### Mission Alignment: A Founder Who Lived the System

This is not theory for Iecusoft™.

Our founder — a Service-Disabled Veteran, Chapter 31 Vocational Rehabilitation graduate, and survivor of PTSD, addiction, and suicidal ideation — is a direct product of the systems our contracts support.

He was diagnosed with cancer the day his son was born. He battled depression, alcoholism, and survivor’s guilt, eventually attempting suicide. He entered the VA’s Intensive Outpatient Program (IOP) and began to rebuild — body, mind, and purpose. Through Chapter 31, he earned a Bachelor’s Degree in Project Management while healing physically and mentally.

Today, he leads Iecusoft™ not just as a federal contractor — but as a gatekeeper.

“If I can help just one veteran live through today,  
then every surgery, every night of drinking, every breakdown —  
it was all worth it.”

He also founded One K9 Corp 501(c)(3), a veteran suicide prevention nonprofit that feeds over 300 veteran families each week.

Our technical approach isn’t theoretical — it’s survival turned into structure. It’s a mission carried by someone who lived it, came back, and refuses to leave others behind.

### Technical Compliance Systems

#### Real-Time Compliance & Operational Transparency

Iecusoft™ provides unprecedented visibility into every operational component of our security contracts. As part of our “Transparency Standard,” we integrate a full suite of compliance tools into our daily workflow and grant the Contracting Officer a live read-only seat in our ERP.

#### System Components

##### 1. Monday.com (ERP + Workflow Management System)

All contracts are built into a centralized, live ERP on Monday.com. This system houses:

- Guard post assignments
- Training logs
- Shift schedules
- Incident reports
- SOP verification
- Live performance metrics
- Audit logs and compliance calendar

Contracting Officers are granted a read-only client seat with real-time visibility.

##### 2. SecurityGuard app Integration

Each site’s guard operations are linked directly to [SecurityGuard.app](#) and fully embedded inside our Monday.com ERP. This mobile-first platform tracks:

- Guard check-ins and check-outs (geo-tagged and timestamped)
- Daily activity logs and post order confirmations
- Customizable post orders with daily guard acknowledgment
- Incident reporting with photo/file upload directly from mobile
- Scheduled patrols with GPS-tracked route completion
- Automated shift scheduling and live coverage alerts
- Supervisor site inspections logged and tracked
- Panic button alert system with real-time escalation tracking
- Guard profile dashboards (training, certifications, incident history)
- Automated compliance alerts for expired credentials or missing logs
- All data flows into Monday.com ERP in real time
- Contracting Officer can view logs, coverage, and incidents 24/7
- Monthly reports auto-exported to government-accessible folder
- No paper forms — full mobile-first solution
- 50-year archive retention for audits and historical tracking

All data flows automatically into our compliance engine — accessible 24/7 by the government.

### 3. QuickBooks Payroll Integration

All guard wages and statutory expenses (FICA, FUTA, SUTA, Workers’ Comp) are processed through QuickBooks. The payroll ledger is linked to Monday.com so Contracting Officers can see:

- Guard pay rates
- Hours worked
- Fringe benefit compliance (H&W)
- Verification that guards are paid in accordance with SCA Wage Determinations

Oversight & Compliance Flow

- Contracting Officers receive read-only access to our ERP dashboard
- All documents, logs, and audit trails are cloud-stored for 50 years
- Monthly audit files (payroll, post compliance, incident logs) are exported to a government-accessible folder
- Founder salary, app fees, and tech stack costs are clearly listed in Volume 2 pricing

## Iecusoft™ Standard Pricing

Fully Burdened Hourly Rate: \$34.75/hour  
1. Direct Labor – Guard Wages \$20.00/hour

This is the base wage paid directly to the unarmed security guard. It complies with the applicable SCA Wage Determination rates. This wage is processed through QuickBooks and can be verified via the government's read-only seat in Monday.com.

2. Payroll Taxes and Statutory Costs \$3.25/hour  
Includes FICA (Social Security and Medicare), FUTA, SUTA, and Workers' Compensation Insurance. These are calculated in accordance with federal and state regulations and are included in payroll documentation.

3. Fringe Benefits – Health & Welfare (H&W) \$4.50/hour  
Funds required benefits under the SCA, including health insurance, paid time off, sick leave, or cash-in-lieu. Guard benefit elections are managed transparently and documented.

4. Compliance, Legal, and Project Management (Command & Control LLC) \$3.00/hour  
Supports all project management, contract compliance, legal oversight, and operational governance. Command & Control LLC is 51% veteran-owned and manages the federal-facing components of the contract.

5. Charity Reinvestment – One K9 Corp 501(c)(3) \$0.75/hour  
A direct reinvestment into our nonprofit, which supports suicide prevention, food distribution, and outreach services for veterans. Reports and impact summaries are available for review.

6. Profit Margin (15%) \$3.25/hour  
Transparent profit for Iecusoft, well below industry markup standards. Supports risk mitigation, contract execution, and technology stack.

Total Rate: \$34.75/hour

All items above are fully auditable via QuickBooks and Monday.com. The Contracting Officer is granted read-only access to view payroll records, guard logs, and compliance documentation in real time. Monthly audits are exported to a shared government-accessible folder.

All wages and fringe benefits strictly comply with the applicable U.S. Department of Labor Service Contract Act (SCA) Wage Determination assigned to the place of performance. Iecusoft™ ensures all compensation is fully burdened, audit-ready, and aligns with federal wage compliance regulations. All rates and cost structures are transparently documented and can be verified in real time through our ERP platform. Monthly audit files and supporting documentation are exported to a shared folder accessible to the Contracting Officer upon request.

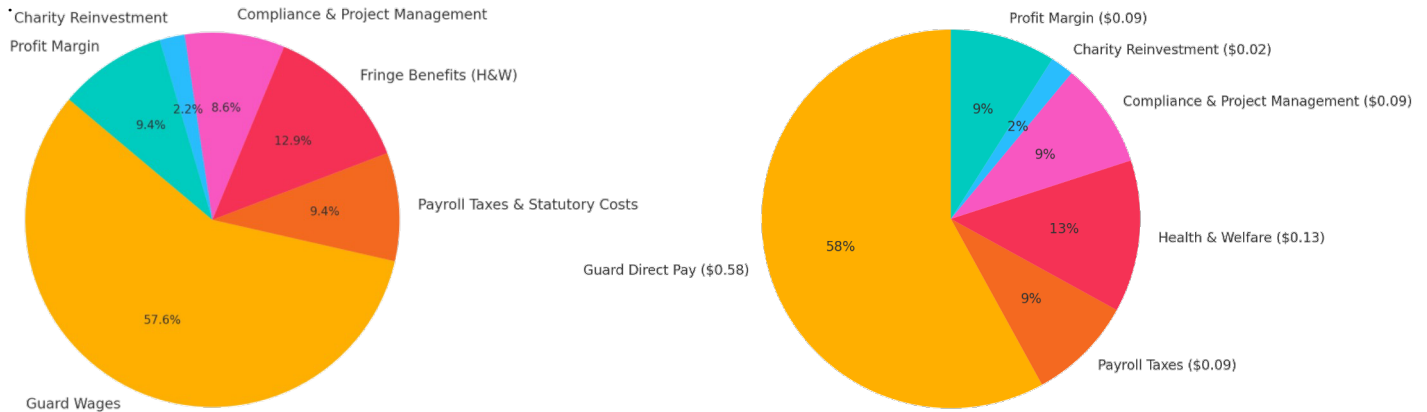
