2. QCP Structure and Execution Framework

- Completes task-specific checklists and photographic validations

Tier 2: Project Manager Oversight

- Conducts weekly performance audits
- Reviews field data for accuracy, timeliness, and contract alignment
- Updates risk registers and issues immediate mitigation orders

Tier 3: Executive-Level Compliance

- Monthly inspections and reporting to lecusoft[™] executive leadership
- Reviews trends, recurring issues, and workforce compliance gaps
- Performs high-level root cause analysis and systemic improvement reviews

% 3. Corrective Action Protocols

lecusoft[™] enforces a **48-hour Corrective Action Window**:

- Issue Identified: Triggered by audit, CO feedback, or system alert
- **Documentation:** Issue is logged in Monday.com, assigned a severity level
- Correction: Field operations rectify and document the fix
- Analysis: Root cause documented and shared with executive team
- **Prevention:** Updated training, checklist, or system rule implemented

This loop ensures issues are not only fixed — they are eliminated at the source.

4. Live ERP Oversight: Transparency as a Service

Contracting Officers are granted live oversight of:
