This application must be accompanied by the first year's dues. Dues are \$3.00 per year and may be paid at any meeting during October, November, December. If dues are not paid by the end of the second meeting in December, you will be dropped from the membership roll. You must also present yourself to the membership at a regular meeting before your application is voted on. You have two (2) meetings to present yourself. If you do not present yourself, your application will be dropped. The only exception to this rule is work or circumstances beyond your control (i.e. a death in your family).

All new members are placed into the Auxiliary Membership for a probationary period of not less than one year (with the exception of Jr. Firefighters). Having met all requirements after one year, you will be placed into the Regular Membership so long as the Regular Membership rolls are not full according to the By-Laws of the company. If you fail to meet the requirements of regular membership, you will remain on the Auxiliary roll for no more than three years or until the requirements are met. If you fail to meet the requirements after three years, you will be dropped from the roll. You may re-apply at any time.

While in the Auxiliary Membership, you will have all rights as a regular member except as outlined in the Constitution and By-Laws. To become eligible for regular membership you must, while in the Auxiliary, attend twenty (20) percent of fire calls, work/drill nights, participate in other Fire

Department sponsored functions and attend fire training as required. Social Members are excluded from required fire training.

AUXILIARY MEMBER

Members voted into the department will have one (1) year probation period, during which time he/she will have to attend 20% of Fire Calls, Drills, Activities and attend Fire Training. Fire Training will be paid for by the department upon successful completion and the auxiliary member may be subject to a commitment of service to the department.

The trial committee will review all records and make a recommendation to the department regarding admission to the regular department. If all requirements are met, the person will be moved into the department on the trial committee's recommendation – no vote required. If the requirements are not met, that person will be placed at the bottom of the auxiliary list and be on probation for another year, with the same requirements to be met again. If requirements are not met on the 3rd year or 3rd time, he/she will be dropped from the department.

Training Requirements:

1. He/She must attend Fire Training programs approved by the Fire Department.
2. Essentials of Fire Fighting paid for by the Fire Department upon successful completion and submission of the required certifications.
3. Training set up by the Chief, Training Officer or the Department.

Activities will include but are not limited to fundraising events, dinners to raise money, gun bashes and numerous other fundraising activities.

COMMITMENT TO SERVICE: The Fire Department will pay for successful completion and submission of certifications for required training. The member will commit to 2 years of service for any training paid for by the department that exceeds \$100.00 from the date of payment.

I understand that If I do not fulfill the required COMMITMENT OF SERVICE, I will be required to repay the department any monies paid on my behalf for training.
