The allocation of such risks remains with me; not the Organizers.

I am over twenty-one (21) years of age or am currently active duty U.S. military. I am legally able to possess a firearm.

<u>I have read and understand</u> the provisions of this WAIVER, RELEASE, COVENANT NOT TO SUE, and EXPRESSED ASSUMPTION OF THE RISK and I have executed this instrument voluntarily on the below date. I recognize that the Organizers are not required or obligated to permit me to participate in any of the Conference events and activities and may terminate my participation in any such event or activity at any time and for any or no reason.

The effect of this instrument shall not preclude the prosecution of any claim that I might have against persons or entities other than the Organizers. In other words, I am releasing, waiving my rights and agreeing not to sue SNIPER CONFERENCE CONSULTANTS, THE TACTICAL FARM, LLC, its officers and/or members and/or subsidiaries and/or landlord and/or agents.

I further agree to allow photographs and videos of my performance to be used by the Organizers, at their discretion, in any advertisement, production, television broadcast, or printed material associated with the business of the Organizers.
