

TERMS & CONDITIONS

Move Around Transportation Corp DBA FortMillConnect.com Will provide scheduled transportations for children pursuant to the following terms and conditions:

- Upon acceptance of the contract, Move Around Transportation Corp DBA FortMillConnect.com agrees to provide transportation for children to and/or from the designated location. Transportation shall be provided in accordance with the rules and regulations applicable in York County and the state of South Carolina. Though we will always strive for on-time performance, please note pick-up/drop-off times are + / - 10 minutes of scheduled times (s) due to traffic, weather conditions, late children, mechanical problems, etc.
 - Fees for prepaid trips are non-refundable
 - All rates are based on destinations located within Fort Mill and Rock Hill area. Each additional for pick ups or drop offs out of those areas will have additional charge per mile.
 - \$25.00 return check fee.
 - Only money orders or cash will be accepted after one returned check.
 - 24 hours notice will be needed for any service or additional request that may arise.
 - In Case of last minute emergency and your child will not require transportation as scheduled, notification must be made to Move Around Transportation Corp DBA FortMillConnect.com office no less than 1 1/2 hours prior to pick-up.
 - It will be the parent's responsibility to contact our office if scheduled pick-up has been cancelled.
 - If you don't cancel your trip before our vehicle is on the location for pick up, there will be \$10 fee for no show at your pick-up on time -- so PLEASE call as early as possible.

- FortMillConnect.com will not provide refunds or credits for any unused rides due to absences, cancellations, holiday breaks, teacher work days and sick days.
- Our rates are cost effective because are based on children transportation only and group transportation (not taxi or limo fares). We will do our best to provide reasonable drive times and safety for your children.
- If for some reason FortMillConnect.com fails to pick up your child due to an emergency situation, you will be immediately notified and credited for that ride on our next statement. If FortMillConnect.com is unable to continue to provide transportation for any reason, you will receive a notice 10 business days prior to the stop date for transportation and all unused payments refunded.
- Children must remain seated at all times while the vehicle is moving
- Seat belts or child restraints are required for all passengers while riding with our vehicle. We reserve the right to suspend or terminate transportation for any child not cooperating with the seat belt usage. In accordance with the South Carolina State Law, children under 8 years of age or less than 80 pounds are required to be in a child restraint seat or booster seat based on guidelines set by the National Highway Safety Department.
- Loud noises or inappropriate behavior will not be tolerated
- Please instruct children to only get into our (marked) vehicle. Our Vehicles are white color and are marked with logo of FortMillConnect.com.
- FortMillConnect.com is not liable for the health, welfare and safety of your child once the child reaches the agreed destination.
- If Parents are not at home at the prearranged time, you will be charged for another trip and you may be late for your activities.
- FortMillConnect.com reserves the right to cancel this agreement at any time due to disciplinary problems with a child while riding in our vehicle. We also reserve all rights to cancel any memberships if more than three (3) no shows without notice.

- Repeating Weekly Rides Service Fee: The first month's payment for the all scheduled rides is due at the time service contract is signed between FortMillConnect.com/M.A.T and Parent/Custodian. Thereafter, payments are made per month, on or before the agreed date or expiration of scheduled rides.
- Repeating Weekly Rides Service Fee it is not refundable if pre scheduled rides are canceled less than 24 hrs before the first scheduled trip.
