Hi Mike,In addition to Ronda's remarks below, I would add:

*PG&E should assume responsibility for recording costs and transfer taxes (if any).

Board: water company to pay applicable and required fees. We will not pay shareholders' legal fees.

•The PG&E indemnification paragraph should include a defense undertaking "Grantee agrees to indemnify and defend..."

Board: This is standard contract language. We are working with PGE's Land Division on this.

Board thinks new language is unnecessary.

The last request was adding in the sentence about implied warranty and fitness for use. I have asked David at PG&E in same msg this morning about adding it in, but think is unnecessary since is just an easement, an empty piece of land, not a machine or some functioning item. . . I wanted to speak to the attorney about as well as the fact this is the same easement for the water company that has already "demonstrated fitness for its intended use" as mentioned above.

 The grantee disclaimer of representations and warranties as to the fitness or suitability of the easement rights should be included.

Board: NAMWCo has a 38-year history of maintaining the fitness/suitability of easement rights.

ITCC tax is scheduled to increase to 34% January 1, 2014...contract price is only valid thru 12/31/13...
