The meeting was called to order at 7:07 p.m. by the president, Mike DiPietro.

1. Review of the Minutes: The minutes of the January 22, 2015 meeting were reviewed and approved.

2. Financial Summary: Jim Armstrong (01/31/15)

Checking: \$ 40,540 Chase \$133.614

February 28 is the end of the Fiscal Year 2014

Jim suggested the board uses Dropbox shared folder for document archiving and transfer: dropbox.com.

3. Secretary's Report: Tim Burke

- **a**. Tim said he needed a financial report to prepare the **571-L** unsecured property tax form for Santa Clara County. Newest asset is Well 3. Cost is \$208,861.91. Jim to provide the report.
- b. January Water Production Statement for Well 2 indicated low usage. Well 3 doing most of the pumping.
- c. Insurance discussion: the insurance company said that outside contractors must have a certificate of insurance. Chappell Pump and Chris Carrera have insurance. Steve Keen is looking for insurance. Tim to find out if our contractor can be attached to our policy with a rider; what the insurance company recommends; what the limit of liability would be and the cost.
- d. Discussion of the use of Roundup herbicide (glyphosate): Hebicides accused of reducing the populations of monarch butterflys and honey bees by eliminating their habitates. *LA Times*: Limits sought on weed killer...to help monarch butterflies. *Reuters:* Heavy use of Roundup linked to health dangers-U.S. study. *National Geographic*: "Milkweed is in decline...a victim of the human battle against weed. Board agreed not to use herbicides around Well1.

4. Maintenance Report: Alan Heinzen

- Water Meter Discussion: Ultrasonic water meters or non-mechanical meters were discussed. Dave said the cost will be similar to the standard meters, but there are no North American vendors. Replacement would minimize water loss and provide more accurate readings.
- Check for meter slippage Alan will begin testing meters in-line at his residence and Mike's residence. Must find out the availability of C. Cassera. Streets to be shut down temporarily.
- · Alan asked about the status of a maintenance credit account with Jim.
- Discussion: provide Steve with an iPad/note book, or laptop and spreadsheet software for meter reading.
 Will this work?
- Leak Detector for Upper Butch to be called when weather permits.
- Well 3 has a leak at the vacuum breaker.
