The meeting was called to order at 7:25 p.m. by the president, Mike DiPietro.

1. Review of the Minutes: The minutes of the December 18, 2014 meeting were reviewed by the board and approved. There was no double dipping.

2. Maintenance Report: Alan Heinzen

- Upper Butch: all service connections have been changed; the leak has slowed. Ready to call Leak Detectors.
- **Well 3**: the well is running the system. The plan is to run the other two wells once a month for maintenance and testing. Operating plans located inside the panel box.
 - Well 3 receives a call signal from the Lower Butch Tank and Double Tanks to provide water. Well 3 then signals Well 1 or Well 2 to pump if they are operational. Wells can be run manually from on-site switches.

Leaks

- Bridle Path Drive (below Kaneko) from an isolated water connection.
- Dr. Andre (Boleo) leak on resident's side. Alan said leak may have been caused by problems with Well 3 water hammer. Board agreed customer's bill to would remain unchanged.
- Storm drain repair: Mike received a call form shareholder Nothman who requested that the water company repair the storm drain on Estates Drive. Board agreed that this is the county's job.

Review of meter readings:

- Abbasi: zero meter reading may indicate meter problem.
- Readings from the three zones and total usage indicate water loss still @ 20%.
- · Alan to test meter slippage at his residence and Mike's.
- Discussion of electronic meters. Provide Steve Keen with an iPad/note book, or laptop, with spreadsheet software. He can calculate water usage as he does meter readings.

Facility and general maintenance:

- Board discussed the use of herbicide *Roundup* to control weeds around well and tank sites. Discussion of pro and cons. Tim to investigate.
- Joe said his gardener may be available for landscape maintenance.
- · Maintenance and electronic items to be stored at Well 3 site.

Insurance:

Alan said that Steve does not have insurance.
 Tim to check with the insurance broker.

Landscaping Well 2 easement/Hruby:

- · Discussion of vegetation. Oleander may be poisonous.
- · Dufur landscaping bill \$5K.
- How many trees to plant and what type. Oak or Aleppo Pine
