- Review and approval of minutes for March 18, 2021.

- 3. Financial Report, Jim Armstrong.

Jim Reported: Chase Checking balance \$191,982. Chase Savings balance \$168,649. (FYI Last Month: Chase Checking balance \$182,280. Chase Savings balance \$168,646).

Jim reported he was contacted by real estate agent requesting water company information for a client who was purchasing home serviced by New Ave Water. Agent was directed to Web Site; however, site was not updated and information was not on the site. Joe has not had time to update site. Board agreed for Joe to find someone to hire who can run our web site. He will bring back information at the next meeting.

<u>4. Presidents Report General Discussion</u>: Mike DiPietro.

Assembly Bill, AB588. California Safe Drinking Water Act. Joe and Jim reviewed the issues and agreed that AB588 was basically asking for an extension of the current Safe Drinking Water Act, Mike also agreed. The AB588 will give agencies more time to comply. It was agreed that no action would be taken at this time in support of AB588. Mike will not write a letter of support.

Continued discussion regarding lower Butch tank and the need for more water storage capacity and balancing of the system. Water leak at Roca's @ 2569 Butch. Steve Keen was called, turned off water and repaired leak. Alan was not available. Water leak drained water storage, wells ran until storage tanks were refilled.

Hydrant replacement discussion still a priority. Hydrants that need replacing due to leaking, old hydrants, missing isolation valve, and dwarf hydrants. Continue as an action item on Alan's list.
