JOYFUL NOISE OFFERING

The Joyful Noise offering will now be collected by our children on the **fourth Sunday** from September through May. The children will also sing before the collection. The collection will be divided between the following organizations.

Operation 143

Operation 143 is focused on addressing the issue of childhood hunger. The organization partners with donors, community groups, schools and volunteers to ensure students have food to sustain them over the weekend when school meals are not available. The name "143" represents the universal number for "I Love You," reflecting their mission of care and compassion for children.

Reach Out-Nepal

Reach Out-Nepal helps educate children and women in Nepal. They operate a "hostel" providing housing, safety and education for up to 12 girls. They also operate 4 free learning centers for about 200 children along with many other charities in the region of Nepal. They currently have 23 pastors who pastor to 35-40 churches.

Dear Falkner Swamp Family,

The phrase "separation of church and state" came up recently here at church. It's in the news more often due to a push by "Christian nationalists" – some are cabinet members in the federal government, elected Senators and Representatives, and the clergy they call to Washington DC in support. Many tacitly support Christian nationalism, whether they attend church or not, because they are in favor of all that is being done by the current federal administration.

Christian nationalism is a dangerous movement for our nation and twists faith in the salvation Jesus brings. In brief, it is the desire to overlay our nation's laws with an exclusive worldview and is unlawful due to the Establishment Clause in the first amendment, despite its supporter's insistence that it is legal. "Separation of church and state" is often repeated to make claims against such movements like Christian nationalism.

The phrase, "separation of church and state" is not in the Constitution but was first written by 3rd President Thomas Jefferson in his letter to the Danbury Baptists in Connecticut, on January 1, 1802, responding to their address of congratulations upon his election to President. Thomas wrote: ... I contemplate with sovereign reverence that act of the whole American people which declared that their legislature should "make no law respecting an establishment of religion, or prohibiting the free exercise thereof," thus building a wall of separation between Church & State. https://www.loc.gov/loc/lcib/9806/danbury.html

The words in quotes, the Establishment Clause, will be familiar to you as one of five freedoms accorded citizens in the First Amendment:

Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances.

The Establishment Clause seeks to prevent the rise of a state religion, such as Christian Nationalism, while also allowing people's free expression of whatever religion they may practice. As history shows us, this is a delicate balancing act.

Many will recall the 1962 Supreme Court case, *Engel vs. Vitale*, in which the Establishment Clause was used to fight prayer in public schools. The Court relied upon Jefferson's "wall of separation" to support the plaintiff. While the Court understood the historic government recognition of religion, the majority held that it is "no part of the business of government to compose official prayers" for any segment of the population, even if the prayer is neutral and voluntary. Do you remember your or your parent's reaction to this ruling, and if so, what do you think now?

Separation of church and state is a necessary wall to keep this delicate balance. But that doesn't mean there must be a separation of faith and politics. Texas Representative James Talarico shared in a recent podcast that religion is at its best when it brings a challenge to the dominant powers. He cited religion's successful challenge of powers such as empires and feudal systems of long ago, and more recently American slavery and Jim Crow laws.

Talarico differentiates Christian Nationalism from Christian activism. "Our faith should move from the pew to the streets," he said.

I couldn't agree with him more.
