

Don Brown Bio

Don Brown is a former U.S. Navy JAG Officer and author of fifteen books on the US Military, including three national bestsellers, TREASON, MALACCA CONSPIRACY, and LAST FIGHTER PILOT.

From 2018 - 2019, Don represented Lt. Clint Lorance, the U.S. Army paratrooper sentenced to 20 years imprisonment under the Obama administration, stemming from a firefight on a battlefield in Afghanistan. President Trump Pardoned Lieutenant Lorance in 2019, releasing him from the military prison at Fort. Leavenworth. The Lorance case received international news coverage in Europe and the United States, culminating with the president's pardon on November 14, 2019. Don has authored a book on the Lorance case, entitled TRAVESTY OF JUSTICE, published by Wild Blue Press.

After the Lorance case, Don collaborated with attorney Sidney Powell and another legal team (The Texas Team) on election fraud issues surrounding the 2020 Presidential Election.

The docudrama movie FALLEN ANGEL: CALL SIGN EXTORTION 17 (Triple Horse Studios distributed in 2021 by Salem Media) is based on Don's book, CALL SIGN EXTORTION 17 - The Shootdown of SEAL Team Six (Rowman & Littlefield Publishers).

Don has been a featured speaker at the Ronald Reagan Presidential Library, the Richard Nixon Presidential Library, and the National World War II Museum, and has been a frequent guest on the Sean Hannity Show. He has appeared nationally on Fox News, One America News, C-SPAN, and

other national and local media outlets. He has also authored numerous OPEDs for various national media outlets, including the New York Post, the Washington Times, Fox News, the American Thinker, and the Western Journal.

His most recent book, *OLD BREED GENERAL: How Major General William Rupertus Broke the Back of the Japanese from Guadalcanal to Peleliu* is a 2022 biography and work of military history about Major General William H. Rupertus who commanded the 1st Marine Division in the Pacific War in World War II: OLD BREED GENERAL, co-authored by Amy Rupertus Peacock, is published by Rowman & Littlefield, through Stackpole books, and is the first major biographical work on General Rupertus.

Don practices law in Charlotte and York County and is a member of the North and South Carolina State Bars. He has appeared in state and federal courts all over the nation, including the Supreme Courts of North and South Carolina, the 4th Circuit Court of Appeals, and has filed several cases in the United States Supreme Court. He has served as litigation counsel for Chrysler Corporation and served as general counsel for MorningStar Ministries.
